

THE PARISH COUNCIL OF STUDLEY – STUDLEY CEMETERY

FEES, PAYMENT AND SUMS, fixed and settled under Section 34 of the Burial Act 1852, and approved by the Secretary of State for the Environment.

The fees, payments and sums set out below apply where a person interred or in respect of whom the right is granted is or immediately before his death was, an inhabitant or parishioner of the Parish of Studley, or who had been a parishioner until age or infirmity caused the person to leave the Parish to be cared for in an institution or by relatives or friends. In the case of a stillborn child, where parents (or one of them) are, or at the time of interment were, inhabitants or parishioners. In all other cases the fees, payments and sums will be TREBLED except those set out in Parts 1 and 3 will not be TREBLED where the Exclusive Right of Burial in the grave in question was acquired at the single fee set out in Part 2.

Part 1: Interment

1. For the interment in a grave of which Exclusive Right of Burial has not been granted:

1. For the right to erect or place on a grave in respect of which Exclusive Right of Burial has been granted.
