6. Presentation by Jennifer Rigby, New Century Theatre re Grant Application

- Runs a professional theatre company in Studley. Has put on performances both in the Village Hall and at the High School.
- Is now on the High School Trust and working with the school to give them the opportunity to gain funding.
- Has tried different projects and has lots of ideas. It has taken two years but now starting the Youth Theatre Group.
- Idea is to get children into the theatre offering the best quality at a price that everyone in the community can afford. There will be something for everyone.
- Workshop will be based on the same idea as Glee Club encouraging children who love to sing. There will be a Stage Management Course and they will photograph and log workshops and end of term productions.
- It will be a vibrant, energetic club for children from the age of 5 upwards.
 It is a good time to launch the club during the present depressing economic time.
- Has met with a cluster of Heads. Concerns from some parents that it is taking place in Studley but need to get rid of this attitude and encourage everyone.
- Reason for grant application is to buy technical equipment (portable lighting) to look professional and to take performances out to other venues and reach out to the community.
- There is a performance of Twelfth Night on 11th March 2011at the High School. Leaflets circulated to all Councillors.
- Cost to join Group will be £30.00 for each half term.

Cllr Mrs Redman: Very impressed with Jennifer's enthusiasm when we are losing so many services. Perhaps can be advertised in Parish Newsletter. Cllr Holder: will special needs children be included? Everyone will be welcome.

Cllr M. Redman: Village Festival will be in July, would they like to attend? Yes.

- Has joined the National Association of Youth Theatres and received a lot of information to get funding.
- Would like the kids to take responsibility. If they need something have to go out and get it.
- With the right equipment will be able to put on fantastic shows.

Studley is comparatively economical.

Cllr Weddell: need to find out the cost of business rates for the library building.

Copy of a letter received which was sent by Bidford on Avon Parish Council to David Carter, Strategic Director re Facing the Challenge – Changing Times for Warwickshire Library & Information Services read out by the Clerk.

- Three years ago the figures were pointed out to WCC by Cllr Mrs Wade and Mrs Wersocki comparing Stratford Town Library with Studley. The footfall for opening hours was very good but most Councillors had mis-read the document.
- Query as to whether there will be a public meeting? It is hoped that this time the consultation will be more thorough. The only thing that came out of the last consultation was a reduction in evening opening hours.
- WCC has to make cuts so we need to look at ways the community will be able to run the library. Maybe we need to plan

- how to look after it ourselves with volunteers. Need to look at alternatives and how we can go forward.
- Before volunteering need to know the costs involved.
- Need to put up an argument to save the library but may need a
 two-way plan. Need to look at the cost of closing the library.
 The access road is half owned by the Parish Council and half
 owned by WCC. Need to look at the total package. There are
 often huge bills involved in maintaining an empty building. Need
 to look if it is within our capability to run a library.
- Cllr Rickhards is willing to front a sub committee.
- With services we are likely to lose in Studley such as the Youth Service and Elderly Care should we be looking at a strategy as a whole to see which services we would like to keep.
- If we don't fight for the library we will be considered as a pushover. We need to make a stand on everything. Important to keep on fighting.
- We need to look at the whole Village and what is being taken away. Decimating the community of the Village if we lose the Fire Service, Youth Service, Elderly Care and the Library.
- Clerk to write again to the Leader of the Council as he has not acknowledged or replied to our letter voicing our concerns. Also need to send a letter to WCC concerning our opposition to the library closure.
- Youth Club are in the process of doing a business plan to entice other agencies to use the building to save people having to travel to Stratford.
- Could raise a public meeting to get views and if other issues come out of the meeting these could then be investigated.
- Also form a sub committee to look at strategies for all possible closure in the Village. Need to be able to present something that can be used as an alternative.
- Suggestion to just look at the library first.

RESOLVED: 1. Organise a public meeting on the future of the library.

- 2. Form a sub committee Cllrs Rickhards, Holder, Mrs Wade & Mrs Wersocki to explore possibilities of running the library and organise a petition.
- 3. Clerk to write letter of opposition to WCC and to ask for a reply from the Leader of the Council.
