Min: 2 Application for permission for Poly tunnel at Dunstall Allotments for Mr Dave Morris. Cllr E Holder, plot secretary, proposed the following conditions to be included on the approval of application of the Poly tunnel due to the unusually large size of the structure (40' x 14')

- Not to use sprinkles or leave a hosepipe on, unattended, when watering is carried out.
- To provide a list of names of all the people who will be working on the allotment plot.
- To place a limit of 6 people on the site at any one time.
- Visitors to the site to be under the supervision of Mr Dave Morris or Mr Ian Cargill.
- Visitors to the site to be considerate to other plot holders and to use the designated pathways.

Proposed Cllr P Beaman, seconded Cllr A Smith, voting unanimous that the Parish Council will approved the application for the erection of a Poly tunnel at Dunstall Allotment as it is part of a Community Project. The following amended conditions to be included as part of the approval of the application;

- The Allotment Association to deal with any issues that may arise now or in the future regarding the Community Project and Poly tunnel.
- Numbers of persons working on the Community Project to be limited to 6 at any one time under the supervision of the project leaders.
- The actual size of the Poly tunnel to be confirmed.

Cllr A Smith proposed that the Parish Council to consider not charging for the plots as it is a Community Project for Abbeyfields.
