Min 140: Lorry Route map – Reply from Mark Porter regarding points raised at the last Parish Council meeting. In his opinion as there are no other major routes through Studley best not to change the colour of A435 on the map, but add other routes. Will suggest when next edition is discussed. Traffic data for B4092 show that 2.8% of vehicles using the road were HGV's. Needs to be 10% before the road would be eligible for any weight restriction. May need to carry out our own survey. Clerk to also write to Allelys to deter them from using the B4092.
