Two teenagers were arrested and Studley in Bloom are considering what action to take.

Letter to be sent to the Chief Constable asking for more Police hours at night and to ask how much it would cost to fund extra hours on a Friday and Saturday.

Min 171 Cllr Beaman: Management of Village Hall

Has serious concerns about the Village Hall Management Committee due to age and the active committee members are getting less. Need to get something in place for the management of the Hall and it is difficult to get volunteers. Would like to investigate the Parish Council taking over the running of the Hall with a Committee of co-opted Parish Councillors. Village Hall has gone a long way since the old building and now looking at a business of £35,000 per year. Need to speak to Charity Commission, Solicitor and Accountant.

It is an important issue, need to call a special meeting to explain what is involved and legal implications.

RESOLVED: Cllr Beaman to get information together and arrange a meeting for December. Item also for discussion for November meeting of Parish Council as there maybe implications for the precept.
