Min 149 Confirmation from WCC that County Solicitor instructed to proceed with surrender of the lease at Youth Club.

7. Items for Discussion

- Min 261 Vandalism at the Allotments: serious problems not just at allotments but whole Village. No Police presence. Chairman e mailed Sector Inspector at Alcester to suggest that it would be beneficial if someone could attend tonight's meeting but no one has come.
 - Got to the point where what is happening has gone beyond a joke.
 Ongoing break-ins, destroying sheds, arson, tools missing, slashing poly tunnels. Happens on a regular basis.
 - Question asked what can be done by Parish Council? Can area made more secure?
 - Could be made more secure but at a considerable expense. Signs can be erected that it is not a public right of way and trespassers will be prosecuted.
 - Feel nothing can be done, parents don't want to know where young are, if caught nothing can be done. No retribution. Police should show presence.
 - Children access allotments from top gate in Eldorado Close during daytime. May be an idea to block off access with a substantial gate. If approached children are abusive, no respect for adults or property.
 - More damage in last 12 months than last 30 years.

- Also access from Public Open Space. Hedge has been allowed to overgrow and gaps have appeared.
- Sheds have also been overturned for no reason.
- Allotment Association could be organised then a grant could be applied for or lottery funding. Lot of sources for funding available. National Association of Allotments & Leisure Gardens could help. A room in the Village Hall could be made available to get together and organise association.
- Need to do something in the short term. Suggestion that a meeting could be arranged to discuss what is required such as hedge laying and identify the problem areas. No shortage of manpower if Parish Council will supply the tools.
- Arrangements made for Parish Councillors to meet Allotment plot holders on Friday, 4th November at 9.30am Eldorado Close entrance.
- Agenda item for next meeting.
- Full support of Parish Council if association formed.
- Action: Clerk to write to SSSC asking that parents be responsible for their children. Notices to be put up at Allotments. Lock & chains to be sorted out. Meeting arranged.

Appalling that we have to go to these measures but problems happening everywhere. Plot holders urged to report all incidents to Police. Thanks from the Chairman to all attending.

Min 262 Reduction in services – Redditch & Warwick Hospitals

- Parish Council should do something. A great many residents of Studley, Bidford and Stratford area use the Alex. If services reduced in either Redditch or Warwick problem of getting to hospital in Birmingham or Worcester. Especially difficult for people using public transport and they should not have to travel miles to get to hospital.
- Last time the Alex was being considered for closure it was saved because there had been a serious accident on the M42. Selly Oak hospital could not cope and the Alex was used as one hospital was not enough. Immediately it was said that the Alex was essential.
- Pressure on Ambulance Service would be tremendous.
- If downgraded there would be no emergency treatment. Any treatment would be nurse led and not doctor led.
- Parish Council should be represented at Public Meeting being held at Redditch Town Hall on 10th November at 7.00pm.
- Not every hospital should be a centre of excellence.
- Clerk to write to Worcester Acute Hospital Trust with copy to West Midlands South Strategic Health Authority and to M.P re-iterating all these points. Need to be a sustainable community and be able to access all services.

Min 263 Studley Sports & Social Club: situation is improving, on top of finances, getting more members. Need to discuss how to recover loan payment. SSSC has now received definite information from SDC as to what is required to complete changing rooms to enable the remainder of the grant to be paid. To help with financial burden Clerk to write to ask for loan to be paid back in three instalments of £1000 per month from December to February with final instalment of £500 being paid in March.
