Steve Marchant – Architect addressed the parish council to seek support for a small development of sustainable housing between 44B and 46 Birmingham Road. The development design would include and eco buffer between houses and river. The development would be self build with Mr Marchant reserving one plot for himself to create a code 5 (nil energy house). Mr Marchant seeks the support of the parish council for the outline application with a detailed plan to be submitted at a later date. A public consultation is required by the planners as per local government directive . Mr Marchant is aware that there is a problem with the sewage pipes and is in discussion with Severn Trent to rectify the problems.

The Parish Councillors like the idea of self build Code 5 sustainable homes and look forward to receiving the plans.

Chairman confirmed that WCC had granted most of what had been requested and that he and Councillor Rickhards had attended meeting which had been interesting. The Library needs to be up and running by the end of March 2012. Awaiting release of funds from WCC.

An officer will be allocated to work with SPC during the transition. Funding will be allocated from WCC for IT costs and telephone lines. Chairman received telephone call from Talk Talk who are currently championing commercial events and have allocated Studley Parish Council a grant of between £500-£1500 for the Library project. Details have not yet been received. A meeting will take place on 4 Nov with MP Nadhim Zahawi who is willing to support CITA application for funding of approx £8000 for both Library and Village Hall. Following a bid to the Big Society Fund a grant of £1000 has been made for signage. Training can begin in early February. Sambourne PC also supportive for funding for Library. Meeting to take place with volunteers in near future. No decision has been made as to use of existing building. Clerk to write to portfolio holder Colin Hayfield with concerns
