7. Items for Discussion

Min 37 Library Provision in Studley: County Cllr Mrs McCarthy had a meeting with Edwina Cordwell, the new Head of Libraries. Outlined our problems and asked if she would come to a Parish Council meeting which she accepted. Cllr Mrs Wade was upset at receiving a letter from Ms Cordwell stating that using ward population figures Studley, Bidford and Alcester libraries all appear to meet the Public Library Service Standard for opening hours. Have to consider the impact of any changes on the service for the whole of the county and at present no plans to extend the hours at Studley.

Suggestion made to members of groups that they should all write Individual letters asking for increase in hours as numbers do count. Each member allowed 10 books, suggest everyone take out their quota. Petition to be placed in prominent position in Coffee Shop for everyone to sign. 106 Agreement on Co-op site perhaps money could be used to extend hours instead of being spent on books. Restricted access means residents unable to use computers. Clerk to place further article in newsletter updating residents of situation.

Min 42 Confirmation of renewal of Data Protection.

Min 43 Coventry Airport provision for the Revision of Noise Preferential Routes/ Standard Departure Routes.

West Midlands International Airport Limited (WMIAL) acts as the Operator for Coventry Airport. Undertaken review of NPR & SDR and the proposals are:

- a) Avoid built-up residential areas as much as possible to minimise aircraft noise in various postcode areas of Coventry, Rugby, Leamington Spa and Warwick.
- b) To concentrate departing traffic on least number of routes possible.
- c) To introduce routes which enable the early acquisition of en-route

navigational facility to obtain better accuracy and subsequent monitoring. Also in the process of proposing introduction of controlled airspace at the Airport. Proposed revisions not related to planning application for passenger terminal which is currently subject to appeal. No comments from Councillors.

- Min 44 A480 Squadron grant request 2005 require outcome. Pass to Grants Committee. Also willing to support 'Keep Studley Tidy' campaign.
- Min 45 Electoral Commission. Local Government Elections 4th May 2006 pilot scheme in Stratford which entails the following changes to traditional election procedures:
 - a) Postal voters will not be required to provide a witness signature on the postal voting statement which is returned with postal ballot papers.
 - b) A marked list of postal voters will be made available for public inspection after the election showing who has voted (but not how they have voted). The Returning Officer is already required by law to produce a marked list of electors voting in polling stations.
 - c) Changes have also been made to the design of the ballot paper in order to facilitate the efficient administration of the election.
 - Electoral Commission is required to evaluate local election pilot schemes and publish the findings within three months of the election. Questionnaire will be sent after the elections.
- Min 46 The first Worcestershire County Council Minerals & Waste Development Scheme became operative on 13th April 2005 and the revised scheme will be operative from 12th April 2006. Revised document can be viewed on the County Council's website:
