1. Public Forum: Welcome to the Parish Council meeting from the Chairman Cllr Helen McCarthy: need to start reminding everyone how important the Fire Station and the Firefighters are to Studley. Would like to see Parish Council support a petition which was read out to the Parish Council.

The Parish Council has already indicated their full backing to support the retention of the Fire Station. To be discussed further at the next meeting. Cllr Mrs McCarthy would like to see the petition signed by everyone in Studley. Will also go to Mappleborough Green and Sambourne for their support.

6. Planning Applications for Consideration: with Parish Council's permission this item was brought forward on the agenda (CIIr Beaman refrained from voting)

07/02507/FUL Studley High School, Crooks Lane.

Proposed phased extensions, alterations and improvements to school buildings and campus.

Cllrs Beaman and W. McCarthy left the room whilst this plan was discussed and both refrained from voting.

Residents were given the opportunity to comment on this planning application – summary of their concerns:

- Concerned about 5 phases enough money for phase 1 but not for others. Will take 10 years to complete.
- Loss of Greenfield site and open space.
- Road to tennis and netball courts will be tarmaced and tennis courts will be overspill car park for 89 cars. Will need lighting and will be close to resident's boundary.
- Concerns of hockey pitch being too close to Catholic School. A lot of fencing will be required to safeguard children from hockey balls.
- Three schools in Crooks Lane, concerns about increase in traffic. If flood-lighting installed will be used day and night and therefore will be problem with traffic.
- Objecting that there will be 2 football pitches so close to residential properties. Will be problem with noise, bad language, light and vandalism. Also security aspect with anti social behaviour, policing an issue.
- Commercial Venture with Leisure Centre. Enough facilities within Village already.
- Already rejected in 1999.
- Level of management could be great concern.

Following discussion the Parish Council objected to this planning application for the following planning reasons:

- 1. Loss of amenity and quality of life to properties in close proximity to the football pitches including lighting and noise pollution.
- 2. Affect of the whole development to neighbouring properties. Will cause undue disturbance which will affect the enjoyment of their homes.
- Increase in traffic on already congested roads especially Crooks
 Lane with vehicular movements causing undue disturbance to residents. Especially
 the impact of overspill car park on tennis courts.

Mr C Tsolakides, 26 and 28 High Street, Studley. Conversion of existing retail unit at 28 High Street to restaurant in association with existing use of 26 High Street including alteration to existing shop front.
