6. Presentation by Dr Jacky Lawrence, Strategic Energy Manager, Warwickshire Climate Change Partnership

Studley has shown an interest in becoming a Transition Town which is a Community led initiative by those with a shared concern on how our community responds to the challenges of peak oil and climate change.

The Partnership is made up of local individuals and organisations from the public, private and voluntary sectors. More than 353 people from 145 organisations are so far committed to effectively reduce carbon dioxide emissions through targeted actions in 5 key areas; transport, energy, resource efficiency, adaption, and communications & education.

Presentation is to make people aware and see if there is any interest:

- There are many sceptics and a lot of guess work. Can choose to take action or no action. Leaflets handed to all Councillors.
- Response to question if anyone has noticed any changes in Studley such as flooding is that the water table has changed. Drainage has always been a problem in Studley.
- There is a waste of fuel. WCC goes against ideas as children travel to schools from a wide area.

- We are all capable of endangering the environment but also capable of cleaning it up. We need to work together.
- What can the Parish Council do?
- Several Villages Henley in Arden, Long Itchington and Snitterfield have formed volunteer groups to reduce their community carbon footprint.
- The most active Village is Ashton Hayes in Cheshire. 'Going Carbon Neutral Project' is a community led initiative. They are trying to become England's first carbon neutral Village. Have a lot of support and interest from the world's media and are linked to 150 like-minded communities around the globe.
- Problem is that Studley has a lot of employment sites.
- Conflict of interests as Parish Council is asked to do things but authorities do not help. For example schools, lot of travelling for many children causing horrendous traffic problems, our library may close and residents would have to travel to another area. Studley residents are not able to use the Redditch tip and again have to travel to Stratford. County issues are not helping. Dr Lawrence will go back and ask some questions.
- WCC has 10 electricity display devices which measure how much electricity is being used. Available to borrow.
- Link to Climate Change website can be put on our website and details put in our next newsletter

Thanks from the Chairman for coming to the meeting on such an awful night. Need to educate people, they can save money, but it will be a gradual change.

8. Items for Discussion

Min 371 Youth Club: Cllr Holder to approach youths with a view to forming a Youth Council who would be able to report to the Parish Council. Cllr Beaman: At recent Community Forum meeting problem raised of cars parking outside the Youth Club and in side road. Main problem is parents dropping off school children. Write as before that it is a private road and double yellow lines would not be enforceable. Pool Road car park, part owned by WCC and part by SDC. Suggestion to write and invite Officer from WCC to a meeting together with Anna Stowe, Youth Leader to discuss how to resolve the problem.

RESOLVED Clerk to write in first instance to WCC. Maybe put money in the next precept for improvements. If access from side road to Pool Road car park was opened up it would give people a better access to the shops.

Min 405 Cllr Bacon: Allotments – 6th month review of plotholder and pension discounts. At recent Allotment Association meeting came to Cllr Bacon's attention that 29 plots are let to people who live outside the Parish including 1 person who lives in Kent. A lot of money is spent on improvements to the Allotments and there is £1000pa loss. People from outside benefit from money paid out of our precept. Would like to put forward to the Allotment Association to differentiate between those 'who live in or out'. Those who live outside the Parish could pay full

amount plus a small premium e.g.£22.00 then Studley pensioners could keep their discount. Do not want to discourage outsiders by penalising them but should pay more as fair proportion of precept is spent on allotment improvements. A lot of people are quite happy with the allotment rent.

Proposed Cllr Mrs Wersocki that plotholders who live outside the Parish pay £5.00 pa more for their plot with effect from 1st April 2010, seconded Cllr Beaman. All agreed. Cllr Bacon to put this proposal to the next Allotment Association committee meeting. 6th month review of plotholder: plot has not been cultivated since meeting 6 months ago.

RESOLVED: Plot to be looked at by Councillors and photographs taken. Item for next agenda together with problem of bonfires.

Cllr Beaman: Aldi store has applied for a licence to sell alcohol. Opening hours in planning conditions are Monday – Friday 9.00 to 20.00, Saturdays 8.30 to 20.00 and Sundays 10.00 to 16.00. Licence applied for is every day 8.30am – 11.30pm.

RESOLVED: Clerk to write letter objecting strongly to conflict of hours agreed by Planning Officers.
