1. Public Forum: Cllr Mrs H. Wright

Thank you for the opportunity to speak. Parish Plan complete and finally to be published. Process to submit to SDC. Very complicated document, not as straightforward as other 17 Parish Councils. Will be sent for consultation to all partners and adoption in June and will then become a formal document. Covers 2007-2011, Parish Council needs to choose how to take forward. Meeting with Studley Improvement Partnership and then will become the responsibility of the Parish Council.

Thanks to the Parish Council for their support and to the Clerk and her Assistant for their hard work.

23% return on survey which was proportionally higher than expected making this a significant document with public support. Cannot emphasise how important the Parish Plan is. Supplementary Planning Guidance agreed by Officers that views will be given significant weight when Parish Plan adopted. Several people responsible for a very good collection of photographs. Query about partners. Action Plan cannot be achieved without working with other groups such as SDC, Advantage West Midlands, WCC. Departments need to work together.

Parish Plan is just the beginning of a lot of hard work for the future. Only 6 copies published, but maybe put on the website to enable anyone to download. Would be useful as a reference document. All Councillors need a copy of final document. There will be an executive summary for every resident.

Min 375 Cllr McCarthy: Allotments. Report from Allotment Association was discussed at last meeting. Now proposed in principle that the Association take over the running of the allotments subject to satisfactory discussion. Meeting to be arranged before Parish Council meeting with representatives from Allotment Association.

Min 376 Cllr Beaman: Action Studley Report. Recent meeting with PACT very useful. However very disappointed with Action Studley Report content and presentation. It was never agreed that Studley Parish Council emblem could be used on front cover and Consultant has never attended a Parish Council meeting.

A lot of inaccuracies especially that Parish Council should meet in more accessible places. Shows a lack of professionalism. Ideas that came out are what we already know.

Group decided to employ a Consultant. Wrong person chosen. Cllr Mrs Wersocki attended a meeting where it was decided to spend £5000 for Consultant who would show how funds could be obtained but it seems to have gone off the track.

Cllr Holder – Action Studley minutes of October meeting stated that 'Consultant would not bend to wishes'. Query as to what this means? Public safety was a reason for consultation.

Cllr Mrs Wright – since 1987 a lot of documents have been produced. Common themes identified to give funding more weight for SIP. All documents will be analysed, should this document be included? Should go to next meeting for further discussion. Some valid elements but others are not relevant. Copy of report to all Councillors prior to next meeting.

Min 380 Youth Shelter. Discussed at last meeting and Councillors asked to look at proposed relocation site. Too close to housing, school and may cause unnecessary problems. Not sure which area by Youth Club. Shelter will be far better used by skatepark. Maybe make a decision when skatepark complete.

Agreed to write and say that it was always planned to go by skatepark but Parish Council and Youth Club could work together to

provide additional Youth Shelter to be situated by Youth Club.
