- Min 32 SSSC Loan re-schedule. Conclusions after sub committee meeting:

Loan from Parish Council accrued on the accounts. Should have been paid back this year. Concerns that Auditor may query why

loan was not repaid by 31st March 2005. Should stipulate that it be paid by January 2006 or date when grant received from SDC. Parish Council to ask SDC to notify us when grant is paid. AGM held without writing to us. Clerk to check when meetings held. Lack of ideas and no proposals for growth.

Meeting to be arranged as soon as possible.

Proposed CIIr W. McCarthy that these measures be adopted, seconded CIIr Mrs S. Redman. Voting unanimous.

Min 53 Cllr Mrs Wade: Studley Leisure Centre Fitness Suite

- Last time this was brought up Parish Council were not aware until it was a planning issue. Only knew this time through Leisure Centre minutes of meeting. Need to discuss before it becomes a planning issue.
- SDC pay £70,000 to run Leisure Centre plus insurance and maintenance so no fair competition.
- Existing gym used by local ladies during the day. Gym would not survive if there were a new fitness suite.
- Great concern that there would be another empty business premise in the Village.
- SDC did not appeal when last application was turned down by Arden Area Committee.
- Gym would only be available in evenings as used by school in daytime.
- County Councillor Mrs McCarthy has written to SDC.
- No plans at present unless it can be funded themselves. Suggestion of Management Group not SDC.
- Not on SDC list of priorities.
- Min 54 Cllr Mrs Wade: Traffic Problems, Crooks Lane
 19th April 2005 at 3.00pm fire alarm went off in High School. Fire
 Engine could not get beyond No.6 Crooks Lane. Traffic was grid
 locked. False alarm but it could have been a very serious
 situation if alarm was genuine. Need to write again to WCC with
 copy of fire report. Same problem exists in Manor Road. Seems
 to happen on a number of roads due to irresponsible parking.
 Clerk to write to SDC. People seem to abuse parking. Situation
 to be monitored.
- Min 55 Cllr McCarthy: Siting of bench, opposite Railway Inn, Station Road. Residents asked for bench on the green. Three benches on Park Avenue. Could look at moving one. As concrete may not be cost effective. Clerk to check.
