- Min 79 Alexandra Hospital A discussion took place on the proposed cuts to services at the Alexandra Hospital. The hospital is essential for the whole of the district. It is situated close to major transport links and there is history that suggests that patients involved in serious accidents are often taken to the Alexandra Hospital. There are no direct public transport links to Worcester Hospital and parking is often impossible.

  Proposed Cllr Beaman that a formal letter of complaint is sent to Worcestershire Acute Hospital NHS Trust.
- Min 48 Studley Fire Station A discussion took place regarding the use of the Fire Station following its closure. Cllrs decided they would like to see the Station retained for a period of 12 months before being sold. A possible use for the Fire Station either short or long term could be as an Ambulance Station Point. Resolved that clerk would write to Warwickshire County Council in response
