Min 139 Fire Station Closure:

- Firemen feel they have been treated very badly and the decision to close the Station taken by WCC on 20th July does not make sense.
- Actual closure proposed in September 2013. The decision cannot be reversed but there may be a legal challenge by the Fire Service Union or a change of Councillors at WCC. Posters have been printed and distributed and aware that Nadhim Zahawi has been bombarded with emails.
- When any more information has been received will pass it on to the Parish Council.

- Concerned that Redditch will be losing one of their retained engines which would mean only one engine available to cover their area, which could impact on Studley. Hereford &Worcester will charge every time they come over the border to Warwickshire.
- On a positive note the Annual Fire Station Flower show will be going ahead on 4th September 2010.
- Judicial Review and Legal challenge to be carried out, the process will need to be examined. There may be a bylaw which is being looked at which states a local fire station cannot be closed without a local vote. Working together with the unions
- Need to get facts and figures together with statistics in a form that is hard hitting. Could include something on Parish Councils website.
- Retained firemen at Alcester will be made redundant and the decision has not been consulted on. Only one engine will be available and already disquiet in Alcester about the decision as they could be worse off if the engine is elsewhere. Money has not been included in the Capital Budget for the upgrade of Alcester.
- Lots of confusion at present and need to see what comes out in the next few weeks.
- Thanks from the Chairman to the firemen Mr Crow and Mr Skidmore for attending the meeting.

Min 149 Brickyard Lane Changing facility:

- Email from Redditch & South Warwickshire Combination League stating that an adequate changing facility is required within one mile which should include provision of toilet and washing facilities. There is no requirement for showers.
- Cost to bring the facility to a reasonable standard prohibitive. Need to look at the health and safety aspect.
- Proposed Cllr McCarthy seconded Cllr M. Redman that the area be kept as a recreation ground only. 9 for 1 against.
- May need to look to include refurbishment in next years precept.
- Changing facility to be no longer used until problems are sorted out.
