Minutes of the Parish Council meeting held in the Council Chamber, Studley Village Hall on Tuesday 4th July 2006 at 7.30pm.

1. Public Forum: Adrian Smith & Mr McDermott Evans, Allotment Association Thanks to the Parish Council and especially the Clerk and Cllr McCarthy, for their support over the last six months. Some Councillors have visited the site. Lots of hard work has taken place by volunteers. Water has been installed on Station Road and fencing replaced on Dunstall Road. Two or three elements causing a problem outside their tenancy agreement. One at Station Road and one at Dunstall Road undertaking commercial activities. If they get away with it, others will be encouraged. These people are in breach of their contact. One plot at Station Road not being used and there is a waiting list. Some plots at Dunstall being used for rubbish/burning. Plans for these plots to be used as a car park. Letter to be sent to all offending parties who are in breach of their contract. Allotment Association do not wish to take on the mis-management aspect but will keep Clerk informed. Letters to be sent out then action will be taken after 14 days. 7. Min 77 Studley's War Dead: Thank you from Steven Barley for being invited to the meeting. What started as a hobby is now an obsession. Started to research names on War Memorial. Not yet finished but has a list of 22 men who were either born or lived in Studley when enlisted, and whose

names are not on the Memorial. Parish Council are responsible for the upkeep and maintenance of the War Memorial. With the events of the 90th Anniversary of the Somme, Mr Barley feels very strongly that these names should be added. Would try and raise money if this is an implication. Question asked if Mr Barley certain that these names are not on other Memorials in other parts of the Country. No criteria laid down. Names missed off as not put forward or relatives had moved away. List is accurate, taken from war records website. Quite disturbing that these names are not included. Should also be read out during Remembrance Service. List handed to Parish Council to follow up. Thanks from the Chairman to Mr Barley for attending the meeting.

- Min 88 Proposed SDC Food Hygiene Inspection Results Rating Scheme (Scores on Doors) comments required. All agreed a good idea. Parish Council will support.
- Min 98 Mis-use of allotment plots: action to be taken recorded in Public Forum. Rabbit problem getting much worse. Difficult to eradicate because of size of land. Quote received for professional help last year but too expensive. Offer of ferrets to be taken up. Members may be prepared to pay £10 each to get help. As SDC own the land maybe ask them if something can be done. Sprinklers are not permitted.
- Min 38 Traffic problems around the Village speed limits. Cutting taken from Mid-week News & Observer passed round. Bidford, B439 will be the first to get reduction in speed limits. Need to find out if Studley missed out on 'A' roads and they are now doing 'B' roads. When A435 is detrunked should go to top of the list. We were told that there was no money available, but money may be directed from WCC but come from elsewhere. Need to talk to WCC. Bidford will be first to benefit from actions as a result of Audit. Maybe Coughton next, in alphabetical order. Write and ask the question and ask for a copy of the audit. A435 has been re-surfaced to roundabout. When is it to be completed with quieter road surface like that through Mappleborough Green? Write and ask Highways Agency when it will be done. Road needs to be made good before handover. Ask for reply within 3 weeks. Need to push for reduced limits to 20mph outside schools. Need to keep pressing.
