Cllr P Beaman read out letter from resident, Mr J Ingram requesting for freedom of information from Cllr Summers, Cllr Mrs J Beard, Cllr Mrs K Somner-Brown & Cllr B Dixon regarding the recent elections when a lot of claims were made about a petition signed by over 1,000 people protesting against the proposed changes to the rules and regulations pertaining to the operation of Studley Cemetery. The following information has been requested;

- What was the petition collecting signatures for or against, specifically the wording used to set out the reason for the petition?
- How many of the Studley residents who participated were listed on the Electoral Role and therefore eligible to sign the petition?
- How many signatures were valid, ie supported with a Studley address and contact details?
- How many signatures collected were invalid according to the rules of petitioning Council.
- Based on the latest electoral role, what percentage of the village supported the objectives of the petition?

Mr Ingram asked in his letter; "Additionally I would like to know when Council will make the audited details of this document public, this is clearly long overdue and I firmly believe is in the public interest?"

Cllr Dixon informed Council that he supports Mr Ingram's Freedom of information request and Cllrs. Dixon, Bear, Summers and Somner-Brown agreed to provide the information requested
