It was agreed to reject the Stratford District Council Dog Warden Proposal and to proceed to seek to appoint and train a Dog Warden to be shared between Studley and Henley in Arden Parish Councils. Clerk to canvass residents.

Min 120: Speeding in Studley

Cllrs Rickhards and Bacon are concerned about the high levels of speeding in Studley and in particular on Bromsgrove Road and Station Road. The Parish Clerk had obtained information from the County Council regarding average speeds which confirmed speeding regularly occurs.

It was resolved that the Clerk would make representations to The Traffic Safety Unit asking what measures they propose to take to deal with and enforce speeding vehicles.
