Formal recommendation received confirming Studley has been approved for the formation of a Community run Library by the Library and Information Service with a capital grant of £6,000 to be awarded. This is subject to all proposed funding and delivery arrangements are in place. It will be discussed at the Cabinet meeting of WCC on 13<sup>th</sup> October 2011. County Councillor Clive Rickhards has every confidence the bid will be accepted. He stressed that he would always support a Community run Library.

This was mentioned at the WALC Clerk and Councillors Liaison meeting on 3<sup>rd</sup> October as Tanya Butcher from the Library Service was present. She is to take our concerns to Property Services as they will be responsible for disposal.
