Min 273 Cllr Mrs Wright: Focus on Studley

- SIP (Studley Improvement Plan) is taking direction from the Parish Plan. Paper outlined on how to practically go forward. Advantage West Midlands invited Group to a meeting in Rugby. Can now go forward for a Leader Bid, tied into Europe, to give to rural communities with a population of less than 25,000. Studley in good position to go forward.
- Have now got an expression of interest number and can go into the first round. £250,000 per year for 5 years. Feels that Studley needs to be regenerated. Thinking is to improve what is already here.
- Parish Council very much a partner/stakeholder.
- 1st round bid needs to be in by 14th December 2007. Canvassing support.
- Fundamentally based on regeneration of Studley as shops are closing down,

- businesses moving out etc. Make the best of what we have got.
- Need to introduce in bid a Village Centre Manager to actively go out and promote the Village.
- Studley has a lot of take-aways and restaurants, could look at Studley as an eating experience like Ludlow. This would come under Tourism. Would need to raise the standards of shops frontages.
- Need support from Parish Council to help complete the form.
- Is there enough time to complete the form? Time is short but need to take this opportunity.
- SDC willing to support Studley together with Shipston who have similar problems.
- If join with Shipston could be geographical problems.
- Also asked for Business Adviser. Training is also important for Volunteer Groups.
- Leader Bid could go on our own or go as part of a joint effort run by SDC. Two separate bids.
- Concern that we don't know enough.
- Could go for all angles, go for both bids then look at in detail when passed this
 preliminary stage. Parish Council need to give support especially when there is
 potential for money.
- Although SDC have committed support to SIP in principal, need to support in detail.
 Proposed Cllr Beaman to support the bid, seconded Cllr Mrs Redman. Voting unanimous.

Min 277 Parish Council Enforcement: following briefing session at SDC, Robert Weeks has not received any expression of interest from Parish Councils who wish to progress to the next stage of training about how they can conduct their own enforcement of dog fouling provisions. Low key enforcement presence is proving successful in other areas and he would like to know of any particular concerns. Min 279 Changes to mobile library services in Warwickshire to take place in January 2008 after the period off the road between 26th November 2007 and 2nd January 2008. There will be five brand new mobile

- libraries with new stock, a new computer system for both staff and public use and better access.
- Min 280 Consultation: Responsive Services and Empowered Communities. WCC and partners are planning to establish a framework of 21 'localities' across Warwickshire through which to seek to integrate responsive, seamless public services addressing the particular needs of each locality. Response of Parish Council required by 5th December 2007. WALC have advised that it is important to respond as some Parish Councils have issues regarding Boundaries. Studley boundary not affected.
