Minutes of the Parish Council meeting held in the Council Chamber, Studley Village Hall on 5th March 2013 at 7:30 pm.

5. Public Forum

a) Mr Brian Dixon, 24 Castle Road reported the following:

- Urged Parish Council to support the idea of a concept for a museum
- Progress of path in grave yard has been done well to thank employees of the Parish Council
- Time frame for the results of enquiry by investigator to the burial ground to be published to the public. Chairman reported that solicitors are now involved and it is out of the hands of the Council. Members of Parish Council will not be able to discuss the matter at all.
- Mr Dixon asked if the investigator's name can be made known to the public. Name of the investigator has already been given to all party involved.
- Mr Dixon would like to know the cost of the investigation. The Council do not know the cost yet.

b) Mrs Beard informed Council that the investigator had only contacted her once and has not received any further communication from the investigator.

c) Cllr H Wright would like to reiterate that the funding that that she is applying for from Lottery Heritage Fund is not for a Studley Museum but a Heritage Project. Cllr Wright explained that the cost of acquiring a building for a museum would be vast and impossible to raise in a short period of time. The vision of the Heritage Project is to celebrate the vitality of the local heritage by ensuring that it is alive and appreciated by successive generations. This will be done through displays of items and interpretation panels of the 17th century Needle Industry in Studley.
