Need to look at protecting the environment and improve the health of residents.

Stratford District Council has no ban on bonfires. Plot holders should notice wind direction and make sure that it is not blowing in direction of Augustine Avenue. Parish Council to request a meeting with the Allotment Association. Clerk to write to Mr Close to keep him informed.
