Question whether they are successful.

16/6 Desire Lines although good idea, will not stop additional paths as short cuts.

17/2 Written agreement should be a planning condition to ensure maintenance of open space areas is continued.

17/6 Accessibility to rear gardens should be restricted.

Opening up areas with poor lighting will not prevent Anti Social Behaviour. Measures sound good but with no response from the police would be worthless.

Open plan layouts could be prone to problems.

Min 129: Traffic Matters, Station Road and Crooks Lane.

Report from County Councillor Mrs Helen McCarthy distributed to Councillors. Cllr A Wade very concerned that Studley Community Infant School entrance is not clearly marked. Motorists need to be Aware where the school is. If the Governors applied feel sure that Something would be done. Parking along Manor Road also a Problem especially for emergency vehicles. WCC should be made Aware.

Since the decriminalisation parking has improved for shops although the waiting restriction signs need to be sorted out. Perhaps a notice on WCC'S notice board in Pool Road Car park could advertise restrictions.
