5. Public Forum

Planning Application No.11/00937/FUL, 3 Highfield Road 4 residents representing the road. Extension of property to produce 5 dwellings which will be attached to other 5 dwellings producing a terracing effect. Not in keeping with the streetscene and overdevelopment. It will be overbearing and cause loss of amenity, parking problems and extension will encroach over the building line of no.5 Highfield Road. Sewage problem previously solved but extra dwellings will make it worse especially during periods of heavy rain. In opposition to STR4 (garden grabbing). Would argue that 5 parking spaces are insufficient. Positive discussion previously in 2006 with planners but this was for 4 flats. Building will be within 1 metre of neighbouring property, guidelines are for 2 metres. Property is unacceptable.

No planning notification was put up outside property.

Cllr Holder: no problems with bulky waste collection. 5 tonnes collected and the cage was full. Some rubbish was left before time. Well used service.

Eden Properties, 3 Highfield Road, Studley. Sub-division and extension of existing property to form 5 flats.

Objection for the following planning reasons:

- 1. Loss of amenity to neighbouring property.
- 2. Overbearing and over development of the site.
- 3. Goes past the building line and is only one metre from neighbouring property should be 2 metres.
- 4. Insufficient parking.
- 5. Loss of amenity space for neighbours.
- 6. Increased flooding risk both storm and foul.

Cllr Beaman to chase up why the planning application was not put up outside the property.
