- i) Professor Barrie Wade explained his proposal for raising funds for the restoration of the War Memorial. The funds will be raised through local school children participating in various literacy challenges. Any shortfall will be guaranteed by Professor Wade.
- ii) Mr Dixon suggested that a plaque should be placed close to the Memorial to acknowledge the contribution of the school children that were involved in the project.
- iii) Cllr Mrs S Redman read out a circulation on behalf of Cllr Rickhards regarding a meeting of the Select Committee on Children's Centres at 10 am on the 14th August 2013 at The Shire Hall in Warwick. Meeting will be open to the public.
- **6.** Jenny Sears-Brown- Acting Community Response Manager West Mercia reported the following;
 - All travel expenses on all call outs to first responders are covered by West Midland Ambulance Services.
 - Insurance & Mot of vehicles are the responsibility of the Community First Responders.
 - Any consumable items such as gloves, oxygen masks & bottled water used during a call out will be replenished by the Ambulance Services.
 - Community First Responders work on a cycle of 4 hours per week/16 hours per month.
 - First Responders response times are in compliance with National targets.
 - Studley Community First Responders have 3 new volunteers and are currently undertaking training.

Professor Wade circulated copies of his proposal on the project to all Councillors. The schedule of the project;

- Mr Owen Finnegan will coordinate the 6 school clusters (Studley, Coughton and Mappleborough Green) who will be participating in the project.
- Project to commence on Remembrance Sunday 10th November 2013.
- All schools will initiate a literacy challenge. Parents and relatives will sponsor pupils' achievements and funds will be collected in the autumn term, 2013.
- Funds raised by the children will be used for the restoration of the War Memorial
- Any other money raised by the general public will be used for the replacement of the paving surrounding the War Memorial.
- Any excess funds raised will be ring fence for future use for upkeep of the War Memorial.
- Professor Wade will coordinate the schools on the project.
- Professor Wade will run a poetry writing workshop in the spring term 2014 for every class in the schools. Some of the work will be produced into a booklet to be sold in the Community Library. Proceeds from the sale of the booklet will go towards the War Memorial Restoration Fund.
- A final reading / celebration evening will be held in the Village Hall.

Proposed Cllr M Redman, Seconded Cllr E Holder, voting unanimous for Professor Wade to coordinate the project with the schools. Parish Council will administer the funds.

Cllr M Redman will be the representative for Studley Parish Council on the Restoration of the War Memorial. Cllr M Redman will contact Studley Royal British Legion for a volunteer to serve on the Restoration of the War Memorial project.
