Minutes of the Parish Council meeting held in the Council Chamber, Studley Village Hall on 6 Nov 2012 at 7:30 pm.

1. Chairman declared the meeting open.

2. Present

3. Apologies for Absence

4. Declarations of Interest

Members are asked to declare personal interests in any item on the agenda. 5. Public Forum

- a) Mr B Dixon of 24 Castle Road, Studley raised his concerns reported in the article in the Redditch Standard dated 26th October 2012 regarding the administrative error of burial plot allocation by Studley Parish Council. He was aggrieved that no action had been taken over the matter.
- b) Mrs Beard read out a letter regarding the distress that has been caused to her by the administrative staff in the Parish Council over the error regarding the misallocation of her burial plot.

The Chairman informed Mr Dixon and Mr & Mrs Beard that an investigation was being carried out and the people concerned in the article would be invited in to meet with the officers of the Council to discuss the findings. Procedures have reviewed and revised and will be available for inspection. Chairman of Studley Parish Council reiterated to all present at the public forum that the administrative error was made by previous administration.

c) Policing of Remembrance Day Parade - Superintendent Debbie Tedds confirmed that there will be a police presence at Remembrance Day Parade on 11 November 2012. There will be 5 police officers, one police officer will be laying down wreath and the other 4 police officers will be there for law and order. Ian Whiting explained the organisers of events such as Remembrance Parade are responsible for applying for road closures, legal liability for all attending the events. The police do not have the power to issue road closure orders. Approved road closure order is a legal document for organisers to close the roads. The national position of the Royal British Legion is that they do not encourage local small branches

of British Legion to organise their own parade but to join other parade in bigger towns. Councillors have voiced their displeasure of the policy made by the National Royal British Legion as they feel the members of the arm forces in small town and villages that have given their life in the various wars should not be forgotten.

- d) Mrs Maureen Rickhards addressed the meeting with a proposal to display some paintings by local artists in the Village Hall. Studley Parish Council welcomes the idea and requested that Mrs Rickhards discuss the matter further with Cllr Mrs A Wade.

Min 118: Dog Warden- Agreement reached with Stratford District Council and Henley In Arden Parish Council to moved forward to supplement the Stratford District Council Dog Warden service by using ground contractor to monitor and take action if necessary whilst carrying out routine duties in the area.

Min 158: Tricia Wellings- Chief Executive of Bright Kids Nursery, informed Studley Parish Council that the old Library in Studley will be developed into a training academy for the training and development of own staff and other educational and community organisations within the locality.

Min 159: Grass verge at the bottom of Castle Road Studley.- Cllr Mrs Redman received an email from a Studley resident concerning parking on the grass verge at the bottom of Castle Road and Wickham Road which is churning up the grassed area and causing visual difficulty for residents exiting driveways and Wickham Road. Parish Clerk to seek advice from the Police and to check with grounds contractor on possibility of erecting some bollards on grassed areas to prevent parking

Proposed: Cllr Beaman, Seconded M Redman. Voting unanimous to discuss parking on green spaces with Police and contractor.

Min 160: Stab Vest for First Responders- Cllr Beaman requested Studley Parish Council consider funding some covert stab vests for Studley First Responders as one member of the First Responders was threatened with knife whilst out on call. The cost of the vest is £140.00 (inc vat)

Proposed Cllr M Redman, Seconded Cllr P Beaman, voting 8 and 1 abstention for Studley Parish Council to fund covert vest for Studley First Responders.

Min 161: English Heritage Grade II listed building – Cllr E Holder requested Studley Parish Council consider having some historical building in Studley listed by English Heritage.

Resolved To have an article in the next newsletter for suggestions from the residents.

Min 162: Sarah Klarner- Request for grant funding. – Cllr Mrs Woodrow informed Council that she is a trustee of the Parish Lands Charity and may be able to assist with funding. Contact details of Sarah Klarner to be forwarded to Cllr Mrs Woodrow.

Min 163: Winter Service in Warwickshire 2012/2013- Cllr P Beaman requested all Councillors read schedule for Winter Service in Warwickshire 2012/2013. Cllr C Rickhards agreed to continue in the role of Snow Warden for Studley area.
