7. Presentation of Millennium Shield & Silver Jubilee Shield Awards

8. Presentation by John Rostill, Chief Executive of Worcestershire Acute Hospital NHS Trust

Min 262 Apology received from Mr Rostill, due to the illness of his mother unable to attend. Another meeting scheduled to take place in January or February. Some of the proposals have been discounted at this stage and further work will now take place to look in more detail at some of the more workable options, together with other ideas that have been presented during the pre-consultation exercise. Intention is to have a formal consultation document available during February 2006 and then to commence the 12 week formal process.

10. Items for Discussion

Min 280 Draft Stratford-on-Avon District Local Plan Review – proposed Modifications. All agreed on Parish Council response:

Policy PR.10/1 Safeguarded Land – Studley Bypass (A435) Modification 16

Studley Parish Council are opposed to taking out of the Local Plan the safeguarding of land for the bypass.

Although the legal challenge at the High Court by WCC has been scrapped it is felt that policies and Governments change and it is important that the land remain for at least the next four years.

WCC may have to consider some form of bypass and this also applies to SDC.

Worcester CC have stated they would retain the safeguarding of land whatever the outcome of the inquiry and this should also apply to Warwickshire.

Proposal STUD.B Alcester Road, Studley

Studley Parish Council feel that as there is no planning brief development can take place anywhere in Studley. As there is no protection a planning brief should be in place even though late in the day.

INSET 2.7 – Studley

Modification 87

Studley Parish Council would not oppose further development on the Poplars Industrial Estate but it is vitally important that the green belt land around Green Lane Farm be retained as a buffer zone between Redditch and Studley.

Message from Chairman handed to all Councillors: the proposed precept has been recommended by the Finance Committee to enable the Parish Council to carry out all of the work identified as being essential. Min 294 Proposal for Civic Lunch. Suggestion that Parish Council have a lunch once a year. It would be a nice thing to do. Some Councils already do it. To be paid for by ticket sales. Public perception may be that this would be public money being spent. Could publicise the fact that this would be no cost to residents. All agreed that if it were for a charitable purpose it would be a

good idea. To be discussed at a later date.

Min 295 Anti Social Behaviour: Inspector Emma Walton will be in Village Hall on Wednesday, 7th December 2005. Problems at Youth Club. Had to close again tonight due to problems with youths. Cllr Mrs Wade attended policing conference at Shire Hall. Tackled Police re lack of resources. Feels very strongly that Community Police should not be put in situation where there is no back up. Cllr Bacon raised some points. Neighbour hood policing a priority by 2008. Raising profile of CBOs. Too late to stop kids. Householders often reported for tackling youths. Situation out of control. Imbalance in peoples' rights. Needs change from Government to allow Police to be more forceful. Villagers are not being supported by Police. It is not anti social behaviour it is bullying and intimidation. People should not be subjected to this kind of behaviour and the situation will explode.
