### 4. Public Forum

Mike Rothery raised concerns about the badly cracked walkway around the War Memorial. He would like to see it block paved the cost of which would be approx £2500.00. He would not like to see tarmac used as it would be cosmetic and out keeping with adjacent block paving. Cllr Redman will make sure the matter is raised at the British Legion Meeting on 11 January 2012 to see what help could be given. The Parish Council thanked Mr Rothery for work already done. #### 5. Items for Discussion

Min 250 Approval of Precept 2012-2013.

£600.00 has been withdrawn from the Village Hall Grant to bring down the increase in the Precept to under 3%.

Proposed: Cllr Beaman that Precept be accepted with amendment Seconded: Cllr M Redman. Voting Unanimous

- Min 251 The formal offer for unmetered electricity connection at Eldorado Close and Grays Road has been received. 2 new columns have already been approved at a cost of £1452.00 + VAT.
- Min 252 Street Lighting A new street light has been requested in Crendon Close. The cost is £1422.00 for connection. Funds are available and no objections have been received from residents as to the siting of the light.

Min 225 Cllr Bacon attended the CCTV meeting on 21 November 2011. Merging with Warwick was discounted. 31 cameras in car parks belong to Stratford District Council. Seeking a contribution of £5770.00 from Studley Parish Council to fund 2 additional staff to monitor cameras. Cllr Mrs S Redman raised concern that this cost would increase year on year as paying wages for 2 additional staff and that the Parish Council shouldn't be picking up cost of whatever services are being reduced. A further meeting to be held in January 2012 which Cllr Bacon will attend. SPC prepared to put in £1000.00. At this time SPC not able to add further £5000.00 to precept and will review at a later time in light of further meetings or options.

Min 253 Residents have requested a grit bin in Crendon Close right hand side at a cost of £141.05.

- Min 376 Cllr Rickhards asked if the Parish Council was prepared to present a motion to WCC to urge them to make sure Library Building does not become decrepit and derelict. Parish Clerk has already written to portfolio holder and is awaiting a reply. Parish Clerk to send further letter and copy to Head of Property Services. Cllr Beaman reported that there will be a meeting of Library
