Litter outside bulky waste collection in hand. Bottles and smashed glass around basketball area. Problems in the Village on Friday and Saturday night. Was reported to Police. There has been an issue of Youths trying to get into Youth Club and banging on shutters. Police are aware.

Recreation Ground full of broken glass. Is there anyway beer can be sold in plastic bottles as it is a serious problem? Disappointing not picked up on CCTV.

6. Nick Ellison, Rob Weeks, SDC – Studley Air Quality Draft Action Plan

Thanks to the Parish Council for help with quest of distributing survey forms. Worthwhile as good input with 60 responses being sent direct to SDC and many handed in to Parish Council office.

Prepared interim report, copy of Pie Chart handed to all Councillors.

Three preferred options out of seven:

- Re-signing long distance HGVs
- Reduce queuing/congestion
- Re-signing local HGV traffic

Two points to clarify:

- timing of declaration there were conflicting dates. Late February area was declared. The Order came into effect in March.
- nature of pedestrian crossing, it is already a Puffin crossing.
- 42% of residents suffered ill health which was made worse by air pollution.
 Main problem is asthma.
- Planning Policy would like to be better managed in future.
- Previously recommended 3000 homes for Redditch that was split between Stratford and Bromsgrove is now unlikely to go through as proposed but to be met by Bromsgrove rather than Stratford area. Considering issue in next few months but final decision will not be known until the end of the year.
- Re-alignment of A435 even if slightly wider would help but very expensive and there would be a lot of disruption.
- Positive or negative effects responses did not perceive any negative effects.
 If proposals were implemented both residents and businesses thought there would be an improvement.
- Further actions:
- most said a bypass was needed, it was not too late.
- Long distance traffic should be banned or discouraged.
- There should be a 30mph speed limit throughout the Village. Some even said 20mph or some sort of traffic calming.
- Desirability for green open space and planting.
- Weight and width restrictions. Sat Navs should be re-mapped. Safer cycle routes needed.
- Could stagger school hours.
- Concensus that Aldi is an unnecessary mistake by SDC. The air quality impact of the Aldi store was the subject of a detailed assessment and it would not significantly change the air quality.
- If A435 improved should not cause problems on other routes.
- Voluntary agreement with Allelys transport but still persist in coming through Village.
- Resumé if things are done it will solve everything quality of life, health, community life.

If actions do not solve everything is there a legal obligation to try something else? Will carry on monitoring.

Could consider closing Station Road entrance off Barley Mow Island and have one way system down Redditch Road to Washford or traffic lights at Spernal and Washford. Principle is to remove queuing.

Transport Planners need to be involved. On agenda is detailed assessment of all the junctions to A435. Cllr Beaman is part of the working group.

Air quality will never improve as volume of traffic will not reduce. A435 is a strategic route therefore HGVs will still use it. Reduction of queuing/congestion will be the best option. Hopeful that other options than re-alignment will be implemented.

Industrial development on Winyates Triangle would impact on Studley and A435 – would any S106 agreement money be available? SDC will try. The development will be subject to air quality.
