Studley Parish Council

Minutes of the Parish Council meeting held in the Council Chamber, Studley Village Hall on Tuesday 7th August 2007 at 7.30pm.

1. Public Forum & Min 132 (with Councillors permission)

Letter of complaint about skatepark received from G. Downie read out at request of residents. Copy of letter from Cllr Mrs Wright that she has written to Nick Ellison, SDC about noise received and noted.

- Complaints from residents concerning noise, horrendous amount of rubbish, motorbikes, shopping trolley also used on skatepark.
- There all hours of night 2.15am 3.45am.
- Being dropped off by parents with cans of drink.
- Telephone Police who have been excellent. Dispersal Order in area, kids are moved on but then they come back.
- Every night is Friday night. Rest of Studley is quiet, but screaming on skatepark, bumping and banging at all hours.
- If residents wanted to move, would not be able to sell houses.
- Skatepark was talked about for 10 years. This is the only place to put it. Discussed and put in newsletters, on website.
- Resident complained that plan was changed and skatepark not sited as on original plan.
- Plan not changed.
- Parish Council are aware of problems which need to be sorted out.
- Parish Council have contacted manufacturer and SDC and now awaiting reports. Can then make a decision.
- Anti social behaviour is unacceptable, need to have a curfew, needs to be supervised. Maybe erect a fence which could be locked 8.00pm until 8.00am. Someone would have to lock it. Not the Police.
- Two suggestions made, first is to keep diaries of dates and times of problems and secondly
 to take registration numbers of cars dropping of kids with bags of drink. Need to build up
 evidence. Perseverance is the answer, keep phoning the Police.
- The facility was wanted by majority of Village and a lot of research was carried out. Some problems of noise can be dealt with but the Parish Council cannot control children, need to go through Police, get an incident no. and then it is recorded and actioned on.
- Residents concerned about retaliation. Can't sit in their own back garden. Incredible that Parish Council sited it there. Why should resident have to sort it out?
- Very difficult, need to look at whole situation.
 - a) Noise discussed today with Managing Director of GBH, it has the best soundproofing.
 - b) Need to discuss possibility of a fence.
 - c) Maybe have a bund.

These are the options to look at. All of the community has a responsibility to report anti social behaviour to Police. Parish do sympathise and the situation is being looked at. The kids are now all in one area and are being recorded on camera making it easier to get evidence.

- Residents need help immediately, not in 6 months time.
- Kids have been told that if they do not behave they will lose the skatepark.
- This has always been a recreation area for children.
- Parish Council did not think it through, resident will be seeking legal advice.
- All agreed that Parish Council need to debate suggestion of a fence to be put on next Agenda. Big issues are noise and behaviour but worse it is an eyesore.
- Concerns that children now have to play football near to the road. Need hedging to obliterate
 eyesore and for safety reasons to prevent the ball going into road. A bund would be better
 but not leylandi

 Residents invited to next meeting and to be kept informed. Also suggestion to attend next PACT meeting.

Chairman: sorry that there is a problem, the Parish Council takes this seriously but please bear with us to sort out as soon as possible.

Members of the public left the meeting with thanks to the Parish Council for listening.

If looking at a fence problem of who would control it. Maybe bund would be better. Need to find out if byelaws are enforceable.

Police patrolled the area last Friday and there were no incidents. However concerns about glass.

Alcohol ban not passed due to technicality. To be resubmitted.

A lot of praise from some parents for the skatepark.

Thanks from the Chairman to PCSO Johnson for his hard work.

Cllr McCarthy: new signs have appeared outside the Barley Mow. Have they got permission? Cllr Beaman to check.
