12. Correspondence

Min 415 Letter received from Mr Francolini – currently working on plans for the Golf Driving Range to re-model the golf centre and wishes to lease the soccer pitches and surrounding land at Brickyard Lane to put in more facilities for disabled people and a family area together with mini golf and a refreshment area.

The Chairman informed Mr Francolini that the Parish Council could not make any decisions this evening but the lease will be discussed at the next meeting.

Mr Francolini:

- Specialises in family golf. The land used to be a tip and there are serious issues with land drainage etc. Proposes to spend £500,000.
- Tried to purchase the next field to extend the disabled area but the price was not accepted.
- Has been in the area for 10 months. Gangs of youths use the area for anti social behaviour. Issues with the pitch, concerned about the amount of dog excrement, syringes, litter etc.
- Would like to lease the Brickyard Lane site and put Studley on the map as the best golf facility in the Country. Plus could bring in Sky championships.
- Would like to improve the site and bring revenue to Parish Council.
- Area would be completely secure and it would also help improve house prices.
- No alcohol licence to be applied for, it is family golf.
- Studley youth can be encouraged to use site for training and may see golf as a sport.
- Interested in bringing in people from hospital and to provide facilities for wheelchair users and for rehabilitation.
- It will not be a membership club everyone will be welcome. All courses are open to the public and are not elitist.
- Lease on golf range is for 75 years.
- All welcome to go and have a look.

Objection for the following planning reasons:

- 1. Policy STR4 of the Stratford on Avon Local Plan Review. Gardens now classed as greenfield sites and not brownfield. 'Garden Grabbing' should be discouraged.
- 2. Against Policy STR2 over provision of housing.
- 3. Drainage remains an ongoing problem. Unless dealt with further, this development will only exacerbate the problem. Another drainage /sewer will not solve the issue and this will affect the amenity of the area.
- 4. Not in keeping with the streetscene.

Cllr Weddell: would also need money for a book fund and maintenance.

Cllr Somner: Has WCC taken into account the fact that Studley residents may be using Redditch Library as their opening hours are better?

Cllr Rickhards: If anyone would like to help with the petition, they will be very welcome.

- a) A Community Right to Buy Assets of Community Value New powers will ensure that community organisations have a fair chance to bid to take over assets and facilities which are important to them.
 - Interesting that when bidding for assets could mean you have to bid against private enterprise. Library and Youth Service are services which could be supported. Would have to put £24,000 onto the precept which is not a lot compared with some Parish Councils. It is not fair to raise precept for something that others are getting. We would be paying twice.

- Covert before and after speed survey.
- 2 week fixed flashing anti-speed sign dependent on fixing to existing street furniture.
- Localised anti-speeding campaign using plastic signs.
- Door to door delivery of SLOW DOWN wheelie bins stickers.
- Full report on the campaign.

Option 2 – Community SpeedAware – FREE, requires local volunteers

- Free loan for up to 2 weeks of a Smiley SID flashing sign to be staffed by local volunteers.
- Full training given on site to a minimum of 2 volunteers.
- Volunteers can be members of the local council/organisations & Neighbourhood Watch groups.
- Signs can be used throughout the community subject to safety checks.
- Full support of the County Council Road Safety Team. Clerk to write and express an interest in Option 2.
- Min 420 Over the next three years WCC has to reduce its budget, including reduction in financial support for bus services. There is no change in the services to Studley and Mappleborough Green.
