12. District, County Council & Delegate Reports.

District Councillor reported the following;

- Electoral Review- Studley will be divided into North & South
- North will consist of the west of Station Road, High Street and east of Alcester Road.
- South Studley will consist of the remaining areas in the village.
- Studley will retain 12 Parish Councillors and only 2 District Councillors instead of 4.
- The changes will take effect in 2015.

District Councillor Mrs H Wright reported the following;

- Draft Core Strategy will be submitted to the cabinet for approval on the 28th April 2014.
- Awaiting approval from the Government for the proposal of 10,800 houses for the area.
- High Speed Rail Link (HS 2)- There is strong objection from residents living in the South District of Stratford on the impact of the High Speed Rail link on their community.
 Authorities such as Parish Councils & District Councils are not permitted to campaign against the project but they are allowed to mitigate the effects.
- SDC have allocated £70,000 to lobby against the impact of the project for affected areas.

District Councillor E Holder reported the following;

- Stratford Licensing Panel has successfully prosecuted a licensee on 10 counts for not running his taxi business correctly.
- Dunstall Allotments- There is only 5 plots remaining for lease.

In the absence of County Councillor C Rickhards his report was circulated to all councillors. County Councillor C Rickhards report;

- Reminder of the elections.
- Budget- The budget produces £92 million worth of cuts over the next 4 years. All parties
 have produced budgets within those parameters. All the budgets were initially voted down.
 Through negotiation the controlling party's budget was then modified where certain things
 were dropped such as removing school crossing patrols and closing 9 libraries. A majority
 was then found for this comprise budget.
- Studley Car Boot Sale- Cllr C Rickhards had a site meeting with an officer on the proposed Sunday restrictions on the parking arrangement. The restriction of parking will only be on Sundays within the vicinity of the Car Boot Sale. Consultation with residents in June.

- Safer Routes to School- Cllr C Rickhards has been working with schools in Studley on the measures of safety during school journeys from the north of Station Road and High Street.
- Parking Permits- residents parking permits are now in operation on the lay-by on Redditch Road.
- Damaged Barley Mow Island- Cllr Rickhards will be making representation to County Highways on the damage caused by lorries going round the island.
- Cllr Rickhards has protested at the inadequacy of the slurry seals put in at various points in the greater area of Studley. Assurances have given that it is only a temporary measure.
- There are various footway improvements either completed or due at various locations in Studley. Any feedback would be welcomed from Parish Councillors.
