7. Presentation by Roger Newham, WCC re A435 detrunking

Welcome to Studley from the Chairman. Here to discuss the detrunking of A435.

- Problems on A435 of potholes, surface breaking up, Castle Road junction dangerous.
 As near to handover Highways seem reluctant to do anything. Advised to approach WCC. Will WCC make sure work is carried out before handover?
- Handover is not imminent, Roger Newham would expect repairs to be done by Highways.
- Surface breaking up needs immediate action. Signage for re-routing, will it be done before or after detrunking?
- Pretty unlikely Highways will fund anything, not duty bound.
- Already a speed limit in Village, need more parking, laybys and crossing. Will be judged on volume of traffic and pedestrians wishing to cross.
- When detrunking occurs requirements will be put into a pot. Seminar held each year for capital programme depending on priority.
- Query into speed limit, Could be 30mph at Spernal with gateway entrance into Village.
 Speed limits need to be self enforcing as Police will object.
- Review of speed limits across the County on A & B roads.
- Following technical review the A435 will be looked at. Then go on priority list. Will not be looked at outside this programme.
- Gateways can be looked at but not sure if can be justified or funded depends on mean speed.
- Parish Council may be able to fund it but WCC may not necessarily be able to resource it
- Review should be complete by this time 2008. Government requirement that appropriate speed limits be introduced by 2011. As part of this community concern will be taken into account and will influence priority.
- Should Parish Council put forward ideas and WCC can put a price on implementation?
- Parking bays could have an impact but pollution and congestion could increase. May look at slower limit near schools.
- Weight restriction already asked for on High Street and also discussions concerning lorry routes.
- Would video evidence help our cause?
- Could the pedestrian crossing be moved near to Tesco? In principle it could be moved but a lot of rules and regulations. Changes have occurred which may mean this could be looked at. As A435 such a busy road not sure if enough of a priority to have it moved.
- Bidford had a lot of money spent and have been successful in lowering speed limit.
- Would be beneficial if signage could be changed to divert traffic away from Studley to Birmingham or M42.
- Query, going back to weight limit re lorry route map. As less than 10% using High Street would not lower weight limit.
- Would it be beneficial to send e mail with relevant points?
- Costing needs to be part of overall issues. Helpful to have an idea of costs. Puffin/pelican crossing £60,000, zebra crossing £20,000, gateway £10,000.
- Air quality control to be addressed as a separate issue.

Summary:

- Attended a County Council meeting and given a presentation by Bryan Stoten, Chief Executive of NHS Warwickshire.
- Attended a Cabinet meeting, the Cabinet endorsed the refocused Vision Statement for the County Council without any opposition from the leaders of the two opposition parties. (Copy given to all Councillors)
- Also attended seminar on the key issue of the Revised Code of Conduct. Main points are that complaints will be dealt with locally at the appropriate local level rather than nationally, a strengthening of the Code as regards bullying and intimidation (by Councillors), Councillors are no longer required to report one another, changes to the provisions relating to confidentiality if disclosure is thought by the discloser to be in the public interest, gifts and hospitality of £25+ will not only have to be registered as personal interests but also declared at meetings for the next 3 years, members should declare interest not only in relation to family and friends but any person with whom they have close association and this includes business associates. One other main change is that members with prejudicial interests can attend a meeting to make representations, give evidence and answer questions, but must immediately withdraw after doing so.
