5. Public Forum

Clir Mrs Wright: Tony Gennoe is on holiday so has asked Clir Mrs Wright to bring to the attention of the Parish Council the planning application for Allelys Holding Ltd for the change of use of a timber store to a Waste Transfer Station. There is no indication of how many skip lorries will be using the site and what route they will be taking.

Cllr Holder has downloaded the details and there will be 5 additional vehicles entering and leaving the site each day. Should not have any impact on the traffic. Planning approval was originally given to Jewsons in 2002 for a small transfer station.

- appliances will be lost. Studley being heavily penalised. 43% of the time appliances are not available but this is not the case in Studley.
- We need to fight the proposals. There will be a union meeting next week to see how to go forward.
- Cllr Barry has order 300 copies of the consultation as they are only available on the website. Option on the form for comments but will not be taken on board by WCC as only key words can be read by the computer. Writing separate letters is recommended
- Some proposals are good but appliance should be kept in Studley. Need to stress that Studley is more efficient. Main bulk of call outs are for flooding and road traffic accidents.
- Wednesday, 21st October 2009 Consultation Meeting to be held in the Village Hall at 6.30pm. Chief Fire Officer will attend at 7.00pm.
- Fire at Sibcas on Saturday. Studley appliance was there first and prevented fire spreading. Otherwise could have been catastrophic.
- Costs £124,000 pa to run Alcester Fire Station. Will cost £1.1 million to run as a whole time station.
- Section 13 Agreement provides cross border cover. Redditch is the busiest station in Hereford & Worcester with 3 appliances and 20 retained staff. They also cover parts of West Midlands. If one appliance out nothing else available.
- Model does not taken into effect 'what if' scenarios.
- Health & Safety Executive are still investigating Atherstone on Stour fire so do not know how they can bring these proposals forward.
- As many of the fire fighters work shifts they are always available. Studley average availability 96%.
- Urban 10 minute response time, rural 20 minutes will fail everytime.
- Will need to arrange a meeting to organise a strategy. Campaign needs to be a co-ordinated approach.
- Chief Fire Officer made statement that people 'do not like to lose the building' but need to make sure it is known that people 'do not want to lose the service'.

6. Mrs Sarah Higgins re Allotment Plot

Letter received from Mrs Higgins concerning the Council's decision to refuse her an allotment plot. Mrs Higgins' contract was terminated in 2007 and she admitted that due to personal problems she had not been able to cultivate the plot but circumstances have now changed and would like to rent a plot again. Although there are not any plots available at the moment there were when she applied last September but she was told she could not have one by the Allotment Association who allocate the plots.

RESOLVED: meeting to be arranged between Mr & Mrs Higgins, Cllrs Bacon and Tedd and the Chairman and Secretary of the Allotment Association to try and resolve this issue.

RESOLVED: Clerk to write explaining that there is a housing monitorium in Stratford so no more houses are being built at present. Sites have been proposed by the Parish Council in the Stratford on Avon Local Plan which is in draft form but should come into effect by 2011. The Parish Council sympathise with the lack of affordable housing in the Village especially for young people but the problem seems to be that housing is only affordable once and there needs to be some mechanism in place to keep it that way. Atcheson Close has a shared ownership scheme run by Jephson Housing and whenever possible they try to offer houses that become available to Studley residents first.
