12. District & County Council Reports.

Studley Parish Council

Cllr Mrs S Redman read out County Councillor C Rickhards report.

- The Cabinet decisions on Integrated Disability Service and also on Children's Centres were 'called in' by the Children's Services Scrutiny Committee and in both cases were referred back to Cabinet.
- In the case of the Disability Service the Portfolio holder agreed to a further consultation because the Matrix setting out the criteria for qualifying for various services had been changed since the original consultation.
- Cllr Rickhards would like the Parish Council to respond to the plea from Izzie Seccombe, the leader of the Council to indicate what their priorities are in the context of £92 million cuts over 4 years. For example does the PC feel that we need to give extra protection to Early Intervention work or perhaps lay the emphasis more on Highway safety in terms of road maintenance?

Clerk to write to Warwick County Council to ask what their strategic planning is to address the funding restraints for the next 4 years.

District Councillor Mrs H Wright reported the following;

• Timescale of Elections- The annual canvas this year was planned for 1st Oct 2013; there will be a delay because the government are requesting a more accurate register to be in place for the introduction of Individual Electoral Registration, in 2014, although the government has yet to make a final decision in November. This system means that there will be a move from household registration to individual registration.

- The register will be published on 17th February 2014.
- The analysis of District Wards under the Further Electoral Review will be published on 15th Oct, 2013 and the consultation period will run until 10th Jan 2014.
- **Credit Union-** The Council has resolved to engage with partners to encourage a credit union offering the best fit with the District needs. It is hoped to begin operating in the area as soon as possible and therefore a further report setting out the preferred approach will be submitted to the Cabinet at its 2nd December meeting.
- SDC District Draft Core Strategy New Proposals Consultation- A number of issues
 have arisen in relation to the new settlement programme at Gaydon/Lighthorne. The
 Parish Councils have combined representation and been very active in objecting to the
 new settlement. If the recommendations to the Cabinet are voted through this will create
 a further delay and compound the vulnerability our District to developers and decisions
 making by the Department.
- Stratford District vulnerability is based on; i) the delay in the Core Draft Strategy. ii) the lack of a 5 year land supply.
- Statement of Community Involvement (SCI)- The Stratford District Council of Community Involvement sets out how and when and where the Council would consult with local statutory stakeholders in the process of planning for the local authority area, both in producing development plans and in carrying out the development control function.
- Noting the changes in the Planning system since the publication in 2006 it was agreed that some amendments should be made. Once the document has been adopted the Council is legally obliged to comply with it. Studley Parish Council has an interest.
- Appointment of the Monitoring Officer- At Full Council on Monday 14th
- October 2013 the appointment of Mr Phil Grafton will be formally approved.

- Cllr E Holder informed that Bill McCarthy would like the bench presented by the Parish Council for the McCarthy's lifetime service to Studley Community to be placed somewhere in the High Street.
