4. Declarations of Interest

5. Public Forum

Robert Clark speaking on behalf of residents of Highfield Road: concerned about planning application no.09/02397/FUL. Feel it is total over development of the site, squeezing two properties onto a small site and not in keeping with present properties. Big concerns as area is prone to flooding from an old chamber which was raised by Severn Trent but has not worked. Combined storm/sewer system and main concern that sewerage is a health hazard. When the rain stops water does not disappear but lies on the land. There will be a hard standing area for cars so less land for water to disappear. This is also a bus route and could potentially be six cars parked on the road making driving difficult. Planning application to be discussed under item 10.

6. Land at Redditch Road, Studley

Colin Staves, Planning Policy, Stratford District Council: trying to get greater involvement with Ward Members and Parish Councils in pre-application

discussions so that local issues are raised and there is opportunity for them to be addressed. Hopefully will be seeing more of this before applications are submitted. Thank you for accommodating the meeting this evening. Question asked if this is a special feature?

It will happen with more significant/major proposals. There are no foregone conclusions.

Stewart Anderson, Director, Retirement Housing Consultancy Ltd: as a Company put together retirement housing schemes. Have a 40 unit retirement village in Redditch. Looking at bigger schemes to provide facilities and a care service at a modest level. Scheme for Studley is in infancy stage and if a planning application is submitted would like support from the Parish Council, District Council and Warwickshire County Council. Have had some discussion with SDC. Would need to get a grant from WCC. Lot of money involved in getting reports and transport/ecological assessments and would like to know if being spent successfully.

- It will be a two acre site with access from the Redditch Road.
- 100 150 residential apartments and a further ten with communicable lounges and kitchen facilities.
- Envisage access and exit onto Redditch Road. Not sure of volume of traffic but less than 100% car ownership.
- A previous planning application for housing on this site was dismissed on appeal. Specified as for industrial use only.
- Due to level of land would be single storey fronting onto Redditch Road with four storey level facing Birmingham Road.
- Even 100 apartments with less than 100% car ownership could still be 78 80 vehicles.
- Comment on industrial use would generate a lot of employment such as care, cleaning, kitchen and landscaping staff.
- Road is liable to flooding, would need road improvements.
- This would be part of the scheme and would be talking to WCC.
- Concerns that there are empty properties in retirement development in the Village.
- Good marketing strategy can offer financial arrangements. More successful than other Companies.
- Maybe some bungalows in compliance with 106 agreement would work with housing associations. Cannot rent properties but can arrange social mortgages.
- Expensive service charges would preclude people. Would like Studley residents to be catered for.
- Every opportunity would be given to residents irrespective of financial situation.
- Cllr Beaman has great concerns about the over capacity of both the Redditch Road and Birmingham Road. It is important that the site be kept for employment.

- Once houses are put there would be complaints of noise of the pressings from the Ricor site. It is not the best place to develop, does not fit well for the Village and the roads.
- It is not a good area for elderly people. Residents in bungalows have a lot of problems from the Nags Head.

Min 218 Scout Hut Fencing: suggestion to have wooden fencing such as that around the ATC hut which does not incur vandalism. Maybe have a prickly hedge such as hawthorn although there could be a problem with growing time. Fence needed so that young people are not intimidated or frightened.

RESOLVED: Clerk to get a quote for a wooden fence to match the ATC fencing. Item for agenda for next meeting.

Min 277 Anna Stowe, Youth Club – quote for marking access road and for goal posts: details received as requested by the Parish Council at last meeting.

Full size goal posts:

The Football Association does not recommend full size goal posts for this age group. Suggest best use could be made of current pen to use as an all year round football pitch and it has floodlights. Youths do not use the recreation ground as the pitch is too wet.

RESOLVED: write to suggest that Youth Club look at alternative options such as the pen and mention to look at the Football Association website. All agreed Parish Council will not fund full size goal posts. Marking for access road:

There is no point in spending money on marking a road that cannot be legally enforced.

puzzled and would like a copy of their full report and to know what is happening in the future.

Cllr Bacon: a group of residents come up with list of issues which need attending to. List should be made available to the public. Too long for notice board but could be kept in folder in Parish Council office so that residents are aware. Feels that if Officers around the table cannot get results will be more difficult for Parish Council staff.
