8. Planning Applications for Consideration (Cllr Beaman refrained from voting)

10/00380/FUL

Vicar and PCC St Marys Studley (Rev R Deimel) St Marys Parish Church, Castle Road, Studley. Creation of new south porch extension to St Marys Church to provide permanent toilet accommodation and additional reception space for visitors and congregation.

No representation.

10/00408/VARY

Sibcas Ltd., Brickyard Lane, Studley. Variation of condition 24 of planning permission S96/0160 to allow the stacking of portable buildings in excess of 2 units high for a temporary period of 3 years.

Objection for the following planning reasons:

- 1. Loss of amenity to neighbouring properties. The containers stacked 3 high are over dominant especially to properties on St Judes Avenue and St Chads Road.
- 2. Health and Safety issue as the containers are stacked very close to the perimeter of the site adjacent to the fences of neighbouring properties.
- 3. In the circumstances the Parish Council feel that there should be no variation to the original conditions of S96/0160.

10/00373/FUL

Mr and Mrs M Tomlinson, 2A Holt Road, Studley. Increase in ridge height of existing dwelling including provision of dormers to front and first floor rear extensions to create additional first floor accommodation. Erection of porch and replacement detached garage to side.

Min 368 CCTV Camera

Improvement Partnership (SIP) but this money has already been allocated. Camera would be focused over scout hut area and can monitor any activity. Good quality camera with an angle of 30° - 60° otherwise will distort pictures. Could feed into Stratford camera room eventually but not at the moment. Monitoring will not take place but film can be used for evidence. Village Hall will pick up cost of ongoing maintenance.

Cllr Beaman left the room whilst discussion took place.

Decision for purchase in new financial year. Advantage of static camera would encompass area where trouble has occurred.

Cllr Beaman recalled for clarification of legal implications.

No problem as long as there are notices that CCTV cameras are in operation. These are already in place.

Cameras in Village Hall have recently been upgraded and can record for 30 days.

Cllr Beaman left the room.

A lot of money has recently been spent on replacing the scout hut fence and it needs protecting.

Proposed CIIr Mrs Wersocki that the camera be purchased, seconded CIIr Bacon. Voting unanimous.

Cllr Beaman returned to the meeting.

Min 377 Changing Rooms – refurbishment and repair. Cllr Beaman met with Peter Janes to check the condition of the changing rooms. Report handed to all Councillors and photographs passed around. Do need some repair as need to be kept to a reasonable standard and the referee's room is unusable. Need an external lockable container for line marking machine and goal nets. Should be a regime where cleaned and checked. Needs research to look at charges etc. and an assessment to see what repairs are appropriate. Cllr Beaman to do costing exercise. Defer until May.

Min 392 Affordable Housing – follow up to meeting with Phil Ward, WRCC
Rural Housing Enabler. All aware that there is one site in the Village
would like to see developed. Planning permission has now run out.
It is an ideal site so could undertake housing needs survey.
Could get some of the NAMCO site developed, it is a Brownfield site.
Must not use Greenfield sites.

Need to take into account vision for Studley. How do we want to develop Studley. Parish Plan argued for diversity. Any development must have 30% social housing. Need mixed economy housing. Parish Council consulted for LDF 2026 but have been ignored, no ideas taken up. A housing needs survey could be carried out but need to look at in more detail. Shortage of usable land. To be looked at a later date following Core Strategy Consultation.

Min 398 Planning Application 10/00266/FUL Haydon Way Farm, Coughton. Proposed change of use from an agricultural building and hardstanding to B8 usage. Amendments to vehicular access and provisions for parking and landscaping. Although not in the Parish of Studley concerns regarding the impact this could have on the A435 at the junction with Spernal Lane and Bromsgrove Road. Cllr Beaman did not take part in the debate and voting on this planning application.

Proposed Cllr Rickhards to object to this planning application for the following planning reasons:

- 1. There is no case for economic development.
- 2. A435 is not capable of taking extra traffic.
- 3. The Stratford on Avon LDF Core Strategy states there should be no further development until the A435 is improved.
- 4. Concrete drive not in keeping with agricultural development.
- 5. The huge trucks leaving and entering the site will cause further traffic problems resulting in highway safety being comprised.
