Min 95 Bollards/Railings outside Tesco. Reply received that railings would have to be 0.45 metres from kerb. The minimum footway width for an urban environment is 1.8metres. Currently asking Tesco if their ram raid bollards can be relocated to 0.45 metres from the roadside. Although other railings in Studley are closer to the kerb this may be historical. Any new railings must be 0.45 metres from the kerbside.

Both sets of the members requested these railings and they should go ahead. A parking bay could be an answer but would cost more. If railings were put in there would be no need for bollards.

RESOLVED: ask new County Councillor to take forward. District Councillors will also pursue.

 - Quotes for stock fencing have been received for approval by Parish Council.
 - Allotment Association has made two unsuccessful applications for grants towards Dunstall gates. Gates are a health and safety issue and would like to work collectively with the Parish Council to get this problem resolved. However there are no funds available this financial year.
 - Would like to know the accurate position concerning plotholder who was refused a plot. The plotholder has been asked to come and see the Parish Council but to date there has been no response.
 - Feels that there should be mutual support, co-operation and understanding between Parish Council and Association.
 - Memo of Understanding taken to Allotment Association meeting by Cllr Bacon states the facts that the Committee are aware of.
 - A number of volunteers involved in tree felling a tree at Station Road that resident complained about. Suggested that a thank you note be sent and £50.00 to cover costs.

Proposed Cllr Beaman that a grant of £50.00 be paid to the Allotment Association towards the cost of felling the tree on Station Road, seconded Cllr Bacon. Voting unanimous.

RESOLVED that, in pursuance of the power conferred by section 137 of the Local Government Act 1972 (as amended) and being of the opinion that the expenditure satisfies the requirements of that section, the Parish Council approves the payment of the sum of £50.00 in respect of the Allotment Association.

Cllr Bacon will ask for acceptance of the Memo of Understanding at the next Allotment Association.

- Grass area in good condition and very little sign of litter.
