# 7. To Pass the Minutes of the Last Meeting

#### 8. Matters Arising

- Min 151 Breaches of development control, Clarkes Green Farm. Owner to submit planning application re bund. SDC may limit development if causing demonstrable harm to amenity. In this case activity does not warrant such action. Will follow up after allotted 28 days for planning application.
- Min 149 Revoking of the lease for skateboarding facility at Youth Centre. WCC to seek observations on the matter and will advise.
- Min 89 Application for water supply from Severn Trent. Quotation

should take 6 weeks.

Min 140 Gypsies, Castle Road. Filling in the area behind the travellers would be a good idea. Gap would need to be retained.

Residents helped previously and may be a solution this time.

Paperwork now complete. Date for hearing 2-3 weeks unless some pressing reason why they cannot leave.

#### 9. Items for Discussion

- Min 177 Clement Keys Completion of Annual Return of Accounts 2004/05. Matters Arising 'The period of notice for the exercise of electors' rights was 1 day instead of 14 as required by the Accounts & Regulations 2003'. Thanks to the Clerk for doing a good job.
- Min 174 Countryside Access & Rights of Way Improvement Plan summary from Cllr W. McCarthy. All agreed on comments to be submitted:
  - Accessibility Parish Council would make case for extra resources rather than taking it from some areas where cover is poor already. No Country Park within easy reach of Studley.
  - Health, Well-being & Social Benefits Doubts that 65% of population ever walk the paths. Would support preparation of local walk packages for doctors. Willing to help prepare these. Some schools would also support and promote.
  - Paths, Networks & Connections strongly support the identification of key utility paths e.g. Abbeyfields footpath.
  - Paths on the Ground part of the proposed action should be bridge work which is not mentioned in the list, but is in the plans.
  - Records, Changes & Mapping is GIS (Geographic Information System) to be phased? Alert WCC that the tenant of Haydon Way Farm took a section of the Green Way from Middletown to Spernall Ash into farm land. County should reinstate it as a Green Way.
  - Strategic Developments & Promotion above-mentioned Green Way ideal for upgrading. WCC should trawl publishers of magazines & booklets for local short walks. Not enough indication of short routes suitable for NHS sponsored walks. Question term 'North Arden' used for north of the County.
  - Tourism & Leisure Monitoring contradiction on pages 28 & 44. Lack of listing of resources for this section.
- Min 77 SDC Local Plan Review Poplars, as a major development site. Not in original plan so should resist as fear of it being an addition to existing area. Vital we preserve green space between Studley & Redditch.
- Min 173 Waste Management Framework two documents. Comments for first one required by 22<sup>nd</sup> August 2005. Details of issues:
  - a) Incineration
  - b) Emissions
  - c) Composting

What needs to be done? Government through WCC should reduce packaging. Encourage public to recycle more and to use kitchen waste for mulching. Need to reduce landfill and increase incineration of non-usable combustibles.

All in agreement that comments be submitted. Second document on Community Involvement to be discussed at next meeting.
