## 6. Paul Harris, Karen Johnstone, SDC Local Development Framework – Draft Core Strategy

General discussion:

- Have taken into account the Industrial Estate in Studley, there will be no big housing development. However Winyates a worry as any development will affect HGV traffic through the Village. Studley is still a lorry route. If goes ahead will need to look at impact and signage.
- Aim 3 of Strategy emphasis is on Market Towns. Resources go to Alcester but none to Studley. Only 4 Market Towns who had funding from Advantage West Midlands. Henley is not included either. Studley would be better being a Market Town.
- Strategy mentions main rural centres including Studley.
- Vision mentions 4 Market Towns but expanded so that planning policies can include other larger rural centres.

- Cllr Mrs Wade concerned about roads. No infra structure for housing, roads through Village very narrow. Should be written into Core Strategy as in need of urgent attention. Cannot leave it all to Highways. Attended meeting of West Midlands Regional Assembly, cannot expect businesses to come to Studley if traffic a problem.
- 'Proven needs of Community' only one success when planning application for another takeaway was rejected.
- Document is only a starting point in planning policy.
- 17 empty properties in the Village no evidence that other businesses want to come into the Village instead of takeaways.
- Planning Inspectors look at whole area and needs.
- Cannot support the vitality of the Village if shops only open from 7.00pm 1.00am.
   Decimates the vitality.
- Planning caused problems, destroyed the shopping centre.
- Corporate Strategy is to support businesses does not disadvantage Studley.
- Vitality of Village, right mix and arrange of attractions, very important. Balance (PP6) is important.
- Can there be encouragement to shops (incentives to help people with rate relief and rent)? Small businesses are at a great disadvantage. Need to get owners to reduce rents.
- Outside remit of Core Strategy but relevant.
