County Cllr C Rickhards report;

I. Budget

- £4 million to escalate to upgrade street lighting to LED
- £3 million for 'School Safety Zone- 20mph limits outside schools
- £4.7 million to match investment from BDUK to extend the coverage of Superfast Broadband.
- Reconfiguration of Alcester Fire Station to enable the Day Crew Plus System to be properly facilitated by September 2015
- There will be ongoing cuts or increased charges in Social Care and in Learning and Achievement.
- Increase charges in School Transport.

II. Safety Campaign- High Street, Studley

• A second school crossing patrol and railings have been secured outside the Community Infant School.

III. Parking restriction- Studley Car Boot Sale

- There will be a consultation on another proposed scheme for Sunday only 8 am to 12 noon parking restrictions in area adjacent to Studley Car Boot Sale.
- Cllr C Rickards will be pursuing various proposal for road safety and parking measures at several points.

IV. Studley Centre

• The Education Dept. at WDC will not be requiring the centre for Special Education Needs. Therefore the Physical Assets will now be contacting Churches Together Group to enter in to a business negotiation for the possible sale of the Centre.

- III. Council Tax- SDC will not be increasing the Council Tax in year 2015/16.
- IV. **Rural Housing Programme** The Councils 2014-15 Capital Programme has been amended to progress Rural Housing Programme Round 3.
- V. **Gypsy and Traveller Local Plan** The District Council is preparing a Gypsy and Travellers Local Plan. It has now been approved that consultation should now be undertaken on the suggested sites. There are no sites suggested in Studley.
- VI. **Discharging main homelessness duty into Private Rented Sector** The Localism Act enables the local authorities to offer accommodation in the private rented sector as a means of ending the full housing duty owed to statutory homeless applicants. A policy has now been approved by the Cabinet but is subject to call in.
- VII. **Parking Service- Service Improvements**. The District Council has retained the management of the Council owned car parks. The management of the service now sits with Street Scene. It is intended to improve the service provided.
- VIII. Assessment on the legal compliance of the Councils recycling collection service.Following the completion of an assessment the current recycling arrangements are to be
 retained as they are considered to provide the most effective and efficient way of
