1. Public Forum:

8. Items for Discussion

Min 376 Action Studley Report:

- Not impressed. On first page 'promote greater networking
- and joined-up thinking'. 'Appoint a Village Champion'. Not sure what is meant.
 Who is this? Who will pay?
- Anti Social Behaviour initiative already taken by Parish Council. Parish Council also supports local organisations.
- Report inaccurate.
- Action Studley has discussed and accepted the report for what it is. Having got the report can now apply for grants.
- Anyone doing snapshot survey will not be in depth, only viewpoints.
- Challenge Clause 3, Page 2. Naïve in the extreme, utterly opposed to those measures.
- Village has got community spirit but feel that report rounds down the Village.
- Idea of fish shop, drapery, café but unfortunately small businesses struggle against large supermarkets.
- Grant of £5000 was insufficient to attract the right consultant. Lack of professionalism.
- Action Studley need to take what there is of the plan to take it forward. They
 must be very disappointed that they did not actually get what they wanted.
- Action Studley could use the Parish Plan. All documents can be used by all groups for funding.
- Query if schools have school councils who could put forward their ideas. Cllr Mrs Wade has met with school councils.
- SCWIG (Safer, Communities, Well-being, Intergenerational, Group) invited students to meetings but did not turn up. It is very difficult to get schools involved.
- Min 10 Redditch BC Supplementary Planning Document. Land to the rear of Alexandra Hospital. Comments required.
 - Some pleasing things but proposed units extend too far South to Green Lane.
 - Access fears have been allayed. Access into main space is nearer Alexandra Hospital.
 - Visual quality cover of trees ok.
 - Positively state public transport needs to be improved.
 - Not sure if B1 light industry would be environmentally friendly contradictory,
 - Query if mentioned doing a reptile survey as abundance of snakes and adders in area.
 - Need to be aware that design layout allows for future expansion.

- Fields should have been used for hospital expansion.
- Very near to Public Open Space. Harm to amenity of unsightly buildings from Studley.
- Sustainable urban drainage systems. Not sure what is meant by Swale (ditch).
 Lot of area is clay and water will quickly run off into Green Lane.
- Renewable energy could look at ground effect heating using car park to heat water.
- Object to three storey buildings should only be two storey.
 Clerk to write with comments.

Min 19 Cllr Bacon: Play Area, Castle Estate

Resident recently complained of children playing football in Gunners Lane. Castle Estate does not have play area. Not family orientated, have to cross A435. Can this be considered. Used to be a cricket pitch at the end of Gunners Lane, could be used for play area or football pitch. This was looked at some time ago Cllr McCarthy looked for open space, some interest shown but would not release land. May look at the land where sewer is situated. If any new development could be included in 106 agreement. Piece of land in centre of Riverside could be used. Included in long term plan in Parish Plan.

11. District and County Council Reports Copy of Parish Talk handed to all Councillors by Cllr Beaman

County Council Report given by Cllr Mrs H. McCarthy Copy handed to all Councillors. Summary:

- Travellers settling in inappropriate places. Reported to Police and the Officer who now
 deals with this problem. County in process of providing extra sites for travellers and
 when these are available travellers can be ordered to move off verges and on to sites.
- Lottery bid for the Library has now been signed by the Chief Executive and has gone in. Will have to wait about 6 months to see if successful.
- Attended a Maintenance & Safety Seminar for the Stratford on Avon area. Cabinet has given the County Councillors £400,000 and it has been decided that perhaps 2 route safety projects should be costed and the rest should go on small schemes that would make a difference to local people such as parking spaces, dropped kerbs etc. Each Councillor is to make 3 suggestions of small projects that might cost £20,000 each and that can be achieved this year. The suggestions will then be voted for. Suggestion for Studley is a sign saying no vehicles over 7.5 tons. except for access at each end of the B4092. This would need a Traffic Regulation Order which would take about 6 months, but which could be done this year. Parish Councillors asked for opinions or any other suggestions. One suggestion is that the yellow lines outside the schools be repainted.
- County Waste Disposal Department is still in the process of negotiating an appropriate financial reimbursement with regard to Studley residents using the Redditch tip.
