Thanks from the Chairman for bringing this matter to our attention.

**Clir Mrs Wright:** recent appeal 14 Marble Alley, change of use to hot food takeaway. Inspector upheld the decision to refuse. Parish Plan was a material consideration and taken into account.

Cllr Rickhards: Parish Plan not the only reason for refusal, within Local Plan sufficient grounds for argument, but welcomes strength of Parish Plan.

Parish Plan now 2 years old and needs updating.

# **6.** Shaun Regan, Mappleborough Green Parish Council: A435 Traffic Problems Was proud to be on Studley Parish Council before Mappleborough Green became independent.

Purpose of attending meeting is to try and make sure that Mappleborough
Green together with Studley and Coughton have a joined up approach towards
the A435 and we know where we are going. After the last public inquiry which
resulted in detrunking it was an excuse for Central Government to do nothing.
Highways Authority did nothing before transferring responsibility to Warwickshire

County Council. On day of detrunking wrote to the Chief Executive outlining history but reply (read out to Councillors) was unsatisfactory. Bypass is the only way forward, but unlikely to happen. Government funding is available from West Midlands Regional Assembly.

- Not taking forward problems just stuck in a process. Need to get together to put forward a case. Proposing getting a fighting fund for lawyers to go through Courts.
- Cllr Mrs Bell: everywhere has 20mph signs and Studley with three school sites warrants a 20mph speed limit. Perhaps the weight of three Parish Councils would be more impressive.
- Shaun: real money in WMRA but not on their agenda.
- Cllr Rickhards: feel that Shaun wants the renewal of a bypass.
- Shaun: if could remove HGV's would be a solution.
- Cllr Beaman: Inspector stated Studley needs a Bypass but were only there to decide if government had a right to revoke the decision. Bypass will not happen.
   Need to stop cars coming in to Studley then Mappleborough Green and Coughton will benefit. Maybe send them through Redditch.
- Still an issue with air quality but no money available.
- Need to put item on future agenda, come up with issues and put ideas together.
- Cllr Rickhards: insist go to WMRA to get on their agenda.
- Shaun: need to get barristers involved.

Cannot do justice to Village in one evening. Need to reconvene at appropriate time to complete inspection.

#### County Council Report given by Cllr Mrs Helen McCarthy

Copy handed to all Councillors.

Summary:

- It is likely that Alcester Hospital will be redeveloped as a Health Centre and not as a
  hospital with patient beds. There will be much improved facilities such as scanning and x
  ray. Ward Manager at Alcester Hospital is fighting the decision but the PCT are adamant
  that beds are a wasteful use of resources and not needed at Alcester. Members of the
  Health O & S Committee to visit the hospital on 10<sup>th</sup> July followed by a meeting including
  representatives of Alcester Town Council.
- A press release has gone out 'Youth travel comes under review'. Young people are being asked for their views to inform the joint panel established to investigate possible options for introducing a concessionary scheme for young people in Warwickshire. Travel, lack of expense is one of the most pressing problems for Warwickshire's young people. - Warwickshire County Council is in the throes of two inspections, the Joint Assessment Review of Children's Service and the Comprehensive Performance Assessment.
- The One Stop Shop for Warwick, incorporating a Post Office and an Information Centre has now been opened at the front of Shire Hall.

transport'. Service currently completes over 800 passenger journeys a month. Now have funding for a fifth vehicle. Clerk to write that article already featured in our newsletter which is circulated to every resident.

Looking for venue in Studley to run programme of workshops covering topics such as eye health awareness, arthritis. Willing to come to Parish Council to discuss. Clerk to write and suggest Village Hall as a venue.
- Min 100 Nick Wild aware of gully grid thefts in Green Lane. Made safe, lids to be replaced at a later date.
- Min 101 WCC to formally advertise proposal to implement changes to the hours of operation of the waiting restrictions on Marble Alley. Copy of the Public Notice and plan received. Clerk to write that the signs on the High Street display different waiting times.

- Min 104 Thomas Guise, Solicitors re lease between Studley Parish Council for Studley Tennis Club, Bowls Club and Sports & Social Club. All leases and documentation received so can go ahead and complete the transaction. Details of costs received. Clerk already written that request for payment be sent to Bowls & Tennis Clubs as previously agreed.
- Min 105 Request for donation from MENCAP. Clerk to write that due to limited funds can only consider requests from Studley Groups.
- Min 106 WALC: investigating the possibility of adding a password protected area to their website for member councils. Clerk already responded that it is a good idea.
- Min 107 Response received from Geraldine Quinney re concerns of Studley Car Boot Sale. Clerk to write thank you for good and informative response but suggest could be proactive when good weather and bank holidays and pay for Police presence to try and alleviate problems.
- Min 108 Heart of England in Bloom judging schedule received. Judging in Studley 29th July 2008. Would benefit with help from other Organisations such as Action Studley. Areas could be cleaned up. Have already asked for volunteers in newsletter. Let down by residents who do not clean up their frontages and gutters. WCC won't spray weeds as harmful to animals. Dead silver birch tree still in library area. Cllr Mrs McCarthy has e mailed to try and get it removed. The Foredraught is also a mess and needs clearing.

Need to get Village cleaned up week before judging. Ask scouts and other groups. Cllr Holder will ask Youth Club for volunteers. If muster up help from youths may take a pride in the Village. Maybe arrange a barbeque first.

Action Studley will send a letter to groups/organisations. Could arrange for a 'flyer' to go to all residents 'Your Village needs you To Tidy Up'. Item for next agenda.

- Min 111 SLCC Summer Seminar 'Sink or Swim' Wednesday 9<sup>th</sup> July to Thursday 10<sup>th</sup> July 2008. £180 for 2 days.
- Min 112 Mike Sheppard re grass cutting. Thanks for getting grass cut at Allendale Crescent, however standard of work by SDC not acceptable. Many complaints received from residents about grass cutting all around the Village and along A435. All agencies need to be told of unacceptable standard for when contacts are renewed. Item for next agenda.
- Min 113 Request for support from Studley Improvement Partnership (SIP) letter received from Cllr Mrs Wright. Copy handed to all Councillors.
  - Last meeting of SIP was attended by Andrew Savage, Service Manager, from County Highways. Resulted in list of requirements being drawn up.
  - Mr Savage has agreed to commit to a budget of £10,000. Work to begin in 3 to 4 weeks time. He feels that the County Council would want to recognise the commitment of the Parish Council and the voluntary sector to the work that is proposed.
  - Therefore approaching the Parish Council for a contribution of £1000 towards the immediate overall maintenance work.
  - As part of conditions for permission of the Co-op site a sum of money was negotiated as part of the Section 106 agreement to be used for public art. This is legally binding and the money cannot be spent in any other way.
  - As part of the process of upgrading the appearance of the Village the Barley Mow island was discussed and it was felt that the Island would be an appropriate place for the use of this money.
  - Also asking for permission for the Studley Parish Emblem to be used on Barley Mow Island as a form of Public Art.

Thanks from the Chair to Cllr Mrs Wright.

Chairman quoted from Auditor's Report that surplus of funds from last year could be utilised for Studley Village improvements.

£1000 to get benefits would be money well spend. Folly not to agree.

Proposed Cllr Mrs. Redman to use £1000 surplus money towards this Project. Seconded Cllr Beaman. Voting unanimous.

- Studley Emblem has been done professionally and already in ownership of Parish Council.
- No historical account or suggestion of what Studley was or is. No mention of the Needle Industry.
- Spoke to Arthur Daniels re Coat of Arm from 16<sup>th</sup> Century but was never registered.
- Signs would be removed from the Island. Design would be worked out by Artist then brought back to Parish Council for a decision.

Proposed Cllr Beaman that SIP use Studley Parish Council Emblem. Seconded Cllr Mrs Bell. Voting unanimous.

  of skatepark to be undertaken. Goal posts to be put back in place. Dead oak trees on
  Millennium Green to be removed and replaced. Dog fouling signs to be replaced and metal
  ones ordered.
- Burial Ground Skip to be replaced. Clerk to contact contractor as many complaints about grass cutting. Clerk to contact family re loose headstone which needs stabilising. Dead branches to be removed from Cherry tree.
- Dunstall Allotments area much improved, most plots now taken. Thanks to the Allotment Association.

 The Contractor has been informed that the laying of the wheelchair path can now proceed as the Utility Companies have reported on the presence or absence of their pipes, cables or

- wires. The Parish Clerk has a copy of all the relevant maps and plans.
- Benches have now been ordered. The Probation Service has promised to help with their installation and with the burning off of the dead brambles on the wild flower meadow section.
- Wildlife Trust will prepare a maintenance programme for the wild flower meadow in particular and the whole site in general.
- WCC footpaths have installed a RADAR gate for wheel-chair users and will repair the path up to the gate.
- The Parish Clerk has confirmed that volunteers working on site are covered by the Council's public liability insurance.
- The ATC, Scouts, Guides and Youth Club have been invited to join in the work. Replies awaited
- Members also invited to help. A lot of work to do and every little helps.
