# 6. Discussion regarding response times following closure of Studley Fire Station – Asst Chief Fire Officer Jim Onions

- Target response times Urban 10 minutes, non urban 20 minutes(Studley)
- 24 hour crew based at Alcester and will be a whole time crew (not retained) so can be on road guicker, believe target can be met
- ACF Onions could not recall any statement from Fire Service which had indicated that the time to get from Alcester to Studley was 6 minutes
- ACF Onions had completed journey from Alcester to Studley prior to meeting within 8 minutes
- Clirs argued that the only suitable route for the fire appliance between Alcester and Studley is A435 which at rush hour times or if there are road works or other delays then it would be impossible to meet the target
- ACF Onions responded that generally fire appliances can get through heavy traffic and if it is a major incident such as a house fire there will be a

- back up appliance from elsewhere in any event. Retained services can be delayed getting to fire station in order to crew appliance due to congestion
- There has been a much greater emphasis on prevention which has reduced amount of call outs
- A lot more time will be spent on training and community work
- If concerns raised about vulnerable person in community fire fighters will visit to talk about fire safety
- 28 available Fire Appliances across the county. Cover is moved around as required and can call on Appliances from other counties
- Fire Risk Assessments for business premises are being carried out. There are 12000 premises across Warwickshire and not sufficient resources, priority is given to where there is sleeping accommodation. Responsibility lies with proprietor to ensure compliance
- Assurance was given at consultation to encourage Young Firefighters.
  Studley Young Firefighters now being dissolved and only option is to travel to other venues which is impractical and costly.
- Member of public informed the meeting that Richard Hobbs has said that the Fire Service would pay for Young Firefighters to attend other stations.
   ACF Onions was not aware of this but would take this up
- £150K lottery funding has been awarded towards Youth Working
- Money has been reinvested from closed Fire Stations in Warwickshire
- ACF Onions undertook to provide to the Parish Council regular statistics on performance

Cllr Beaman thanked ACF Onions for attending the meeting.

#### 12. District and County Council Reports

#### Councillor Rickhards reported the following:-

- Alexandra Hospital Cllr Rickhards has urged Warwickshire County Council to press Worcestershire NHS Trust to consult in Warwickshire
- Cllr Rickhards requested Warwickshire County Council to sign up to the Barnardo's campaign to combat sexual exploitation of children – the request was turned down
- Old Library building in Studley still confidential as to who has acquired building.
- Four Acres Residential Home has been sold to Runwood Homes who operate 50+ homes countrywide. They have a commitment to dementia

- care and will retain the pay and conditions of existing staff. They plan an investment of a quarter of a million pounds into the home
- The closure of Studley Fire Station on 1<sup>st</sup> October 2012 may be delayed for approx 1 week
- Post 16 transport Cllr Rickhards in a group who are looking at possible disadvantage due to increased costs, proposals to mitigate and for alternative transport
- Studley Car Boot Double yellow lines are in place on main roads. In other Closes have been abandoned due to objections
- County Councillors each have £5k available for grants. Maximum of 4 grants per Councillor to disperse between 3 Sept and 26 Oct 2012.
  Criteria for grants is that must be for ongoing projects

# Councillor Mrs Wright reported the following:-

- The Government has decided that benefits be reduced by 10%. Old Age Pensioners will be protected
- Number of Councillors to be reduced from 53 to 35 which equates to one Councillor to 2500 electorate with elections every four years
- Draft Core Strategy responses are available on the Stratford District Council website – most came from Studley with 26 responses
- There has been a reduction in empty homes Studley 59 empty homes between April 2010 and April 2012 a net reduction of 44% (26)
