- On 20<sup>th</sup> July 2010 the Council voted to close Studley Fire Station together with Warwick and Brinklow.
- An amendment to oppose all closures was lost with some abstentions and the substantive motion was carried with a majority of 12 again with abstentions.
- Spoke in favour of the amendment and voted against motion B which closed Studley. The run down of the station might take until 2013 while Alcester is strengthened.
- Grim picture emerging on finance:

35 to 40% cut in local government finance over the next 4 years Pay freeze for 2 years

Savings in Warwickshire of £55 to £86m depending on the size of council tax increases

Some services to go in their entirety

Efficiencies alone will not suffice

Council tax will be a much bigger proportion of income – probably 44% in Warwickshire.

- Still to come October spending review.
- Consultation is beginning on the planned closure of some or all of the residential care homes (eg Four Acres) over a 5 year period.
- Concerned that the extra care housing units to be built and any private sector replacements will not be able to cope with the demands for critical and respite cases.
- Care charges are to rise by several hundred per cent over the next year in 2 stages. For example day care charges are rising from £5.55 to £25.00 per day.

It is untenable for the County to run care homes.

Cllr Rickhards visited Four Acres to get an impression of what is being done there.

Some homes will be sold to the private sector.

Proposal to acquire 20 sites in the County for extra care housing. Concerns that certain categories (not sure how they will be catered for) dementia and respite will be on the increase due to demographic changes. Trying to glean more facts.

Justification is saving money due to pressures on Local Government.

Reduction of up to 40% in funding making a huge difference.

Consultation programme taking in all categories.

## **WCC**

- Min 172 Invitation for 2 representatives from the Parish Council to an 'At Home' Drinks Reception at Shire Hall on Saturday, 25<sup>th</sup> September 2010 6.30pm 8.30pm. Cllr Rickhards & consort to attend.
- Min 173 'Save Warwickshire a Tonne' campaign. Following success of 'Switch it Off' campaign this new campaign aims to raise awareness of how simple measures within the home, garden, business, school and travel can save both carbon and cash. It focuses on energy efficiency by composting and growing your own food with a view for Warwickshire residents, schools and businesses to save a tonne of CO2 over a year. Information to be included in next newsletter.

  Street lights could be more energy efficient. Village Hall will be looking to reduce gas consumption. Will be asking Parish Council to assist with funding. Orbit Housing is also looking to save energy.
- Min 174 2010/2011 Winter Service Review. WCC are currently carrying out a review of winter service provision and would like views of the Parish Council on their service and suggestions on what would be an appropriate service. 1,125 miles of road receives salting on primary gritted routes. Due to budget restrictions unable to increase existing resource without reducing primary routes to compensate for any additions. Priority given to roads carrying highest volume of traffic. Salt stocks have significantly increased to improve ability to grit primary routes at existing levels and meet the likelihood of a severe winter. Grit bins provided by the Parish council are replenished by WCC. Public encouraged to use these bins. Questionnaire to be completed by the end of August. Views from Parish Councillors to be sent to the Clerk
- Min 175 Total Place Workshop (now Place Based Budgeting) to be held in Studley Village Hall on Monday, 13<sup>th</sup> September 2010 10.00am 2.00pm. To be run by Chris Marsh. Date noted by Councillors. Apologies from Cllr Rickhards & Mrs Wersocki, unable to attend. Decision made to cancel visit of Jenny Murray (Min 152) as Workshop will be held before her proposed visit.

- Min 177 Redditch & South Warwickshire Combination League concerning the closure of changing facility and effect on Duck Pond Football Club as they may have to resign from the league and result in a financial penalty. Cllr Beaman has spoken to Sibcas to see if facility could be refurbished cheaper and will pursue. No choice on closure at present time. Cllrs sorry to hear of difficulties.
- Min 178 Studley Village Hall notice received of proposed increase in rent of 5% for next year. Office rents have not gone up in Redditch for 15 years. Need to discuss further and invite delegation from Village Hall Management Committee to next meeting.
- Min 179 NALC: Briefings on Ordnance Survey Open Data to make it freely available to the public and Government Proposals to phase out the default retirement age of 65. Copies to all Councillors.
- Min 180 Legal Briefing to cap billing authorities Council Tax and Parish Councils' precept levels. Copy to all Councillors.
- Min 181 Thank you letter from Studley in Bloom to the Parish Council for all the help and support prior to judging day on 23<sup>rd</sup> July. Results will be known on 16<sup>th</sup> September 2010.
- Min 182 Communities and Local Government Consultation on Local Referendums to veto excessive council tax increases. Ministers have announced a short consultation on the capping of local parish council precepts as part of wider freeze on council tax. This is a matter of serious concern. NALC continuing dialogue with CLC and County Association. Member Councils should respond and make representations to local MPs. Copy to all Councillors for discussion at next Parish Council meeting. Consultation ends 10<sup>th</sup> September 2010.
- Min 183 Studley Baptist Church 'Hope for an Addicted Society' 9<sup>th</sup> October 2010. Invitation to join the Church on that day. No one available to attend
- Min 184 Information being collected to feed forthcoming Fire Futures Review of Fire & Rescue Services. NALC would be interested in finding out Parish Council's involvement and engagement with the Fire & Rescue Service. Clerk has already responded.

- Changing Room Facility Brickyard Lane. Copy of quotes received passed to all Councillors together with details of all the necessary work required to bring the changing rooms up to standard.
- Rooms in very poor condition. 'No Smoking' signs are not on doors.
- Nowhere to store equipment other than the referee's changing room.
- A lot of work to bring the rooms up to a reasonable standard.
- Two quotes received: Electrical work £3614.00 plus VAT General work - £3080.00 VAT not required
- Income is only £300.00. Concern of spending this amount of money when the pitch is not used by local teams.
- Would rather see the money spent at SSSC.
- In present condition should be closed and electricity disconnected.
- There is an ongoing maintenance cost each year, but only produces a loss.
- Ground is often unplayable in the winter.
- Clerk to ask the team what it would mean to them if the area was closed for safety reasons and to check the minimum standard required by the Football League.
- Cost involved in closing the facilities and making the area safe.
- Maybe could be gutted and used for changing only.
- Could look for grants perhaps through the Playing Fields Association (PFA) but with only one team playing may not be viable.

## **Proposed Cllr Beaman:**

- at present needs closing as a health hazard;
- ii) notify the team to see if they still want to use the pitch;
- iii) Clerk to check the minimum facilities required to enable teams to play;
- iv) can then make an informed decision.
- Seconded Cllr McCarthy. All in favour.
