9. Items for Discussion

Min: 61 Awards Evening- Cllr Mrs S Redman thanked all Councillors for their contribution for the bottle hamper.

Min: 70 Renewal of VAS sign- The rental of the sign for 6 months will be £200.00 in the same location. An additional £100.00 if the sign were to be moved to a different location or lamp post. Clerk to confirm if a charge will be applied.

Proposed Cllr J Bacon, seconded Cllr E Holder, voting unanimous for the renewal of sign and to position the sign at the end of cottages by the Railway Public House.

Min: 71 Trees in Pool Road- Community Police Officer has requested for the trees located near the CCTV camera in Millennium Green to be cut back for better visibility.

Proposed Cllr P Beaman, seconded Cllr J Bacon, voting unanimous for Clerk to discuss matter with CCTV personnel Yvette Widowfield if any of the trees surrounding the CCTV are interfering with the cameras.

Min: 72 Christmas lights.

Proposed Cllr J Bacon, seconded Cllr A Smith, voting 9 for, 1 abstention for Clerk to check cost of replacement of 2 decorative festive lights in white or similar to the present ones and to approve the increase in charges for the installation of the Christmas lights.

Min: 73 A Bench for St. Marys Catholic Church.

Proposed Cllr P Beaman, seconded Cllr J Bacon, voting unanimous for the installation of a bench in recognition of Bill & Helen McCarthy's contribution to the Studley Community. Cllr Mrs S Redman to ask Bill & Helen McCarthy during the Awards Evening where they would like the bench to be located.

Min: 74 Lack of information at Bus Stops during road closure - Cllr Mrs M Rickhards raised concerns about the inadequate information of notices at bus stops and the website regarding diverted bus routes during major road works in Studley. It was resolved that Clerk to write to Stage Coach & Diamond for a co-ordinated plan for future diversion. County Councillor C Rickhards requested Clerk to ask Highways what information they provide to bus operators during major road works in Studley.

Proposed Cllr J Ingram, seconded Cllr Mrs S Redman that the application be opposed, voting 7 for, 3 abstention due to over intensification of the site and increase in traffic.

13. District & County Council Reports.

Cllr P Beaman reported the following:

- Planning permission has been granted for the extension to Pool Road Pharmacy no plans were submitted to Parish Council for comments.
- There will be an additional 380 homes in Alcester opposite the Grammar School. Planning have objected to the site due to traffic noise and other reasons. There will be an implication for Studley. Lack of updated parish plan and neighbourhood plan limit grounds for refusal.
- It is therefore paramount for Studley to formulate a Neighbourhood Plan as soon as possible.

Cllr E Holder informed Council that he will be objecting to the application for sale of liquor licence at Bradbury Close. Anyone with further comments on the licence to emailed Cllr Holder.

County Councillor C Rickhards reported the following;

- Children's Centre- the Cabinet have largely accepted the recommendations of the Select Committee on no closure of any of the centres.
- Proposal of a 31% reduction in funding. The Select Committee had recommended ring fencing against further reductions in the upcoming round of cuts. The Cabinet did not accept this as they argued it would interfere with the proper planning of further expenditure reductions.
- Studley will remain open as part of a group covering Alcester, Henley and Stratford but there will inevitably be some diminution in the services offered. The Select Committee will clearly need to argue for the relative deprivation of Studley within the district to be recognised and for the maximum integration of services.
- Road Resurfacing- Unfortunately the much needed resurfacing of the Alcester and Birmingham Road resulted in a confusing situation in relation to bus routes. Information on websites, notices on bus stops (where this was done) and from individual bus drivers all told a different story. This was particular so for the Number 26 bus since the website indicated that buses should go straight up the Bromsgrove's Road. After a day or two drivers began to ignore the diversion and reverted back to the normal route. It would be useful if the Parish Council would protest to the bus companies and Warwickshire Highways so that there will not be a future repetition of this chaos.
- The Budget- Cllr C Rickhards will update Council on details as they emerge but reminded Councillors of the projected £92 million plus cuts in the next four years and the impact of that on top of the savings already made. Many Councillors of all parties think local government has been hit unfairly and disproportionately.
