- Traffic will eventually filter into the fast moving Bromsgrove Road and Alcester Road adding to the heavy volume of traffic already using those roads.
- The retention of heritage for future generations. Landscape can be considered a heritage asset as it has particular local significance in identifying the villages.
- The proposed site is an unsustainable location lacking proper established links to the local settlement.
- It is in the Green Belt, a functional designation.
- It is on a green field site in open countryside.
- It has the potential to destroy field boundaries.
- The landscape is the most valued asset that our communities have, as it has shaped the identity of the villages.
- The "dwellings" would close the gap between Studley and Middletown creating urban sprawl. This was recognised in the Stratford upon Avon District Council Landscape Sensitivity Study, which described such development as undesirable.

13. District & County Council Reports.

County Councillor C Rickhards reported the following;

- **Public Question Time-** a 30 minute time limit was proposed to the Overview & Scrutiny Committee. Questions should be notified in writing to the Chief Executive.
- **Public Speaking** will apply to Council & Cabinet Meetings, 30 minutes time limit, 3 minutes time limit for each individual and 3 days notice to the Chief Executive.
- Motions at the Council Meeting of the 17th Dec 2013- Cllr C Rickhards is proposing a
 motion asking the Council to seek clarification from Redditch on their statement that the
 County Boundary at Mappleborough Green is 'somewhat arbitrary' and should not be a
 'barrier to development' and that dissatisfaction is expressed with the lack of consultation
 with Mappleborough Green residents.
- There is a motion asking the Council to write to various bodies and the Minister requesting that the privatisation of part of the Probation Services does not go ahead and recognising the 'exceptional performance' ratings of the Warwickshire Probation Trust.
- Four Acres- Runwood Homes recently held a meeting with relatives and other interested parties to announce their intention to redevelop the site and to double the capacity of the

- premises. Since this will involve a complete rebuild they intend to remove residents temporarily to Leamington Spa while the building works take place.
- Concerns was expressed by several present that the impact of the removal on dementia patients in particular could be serious. There were some assurances from Runwood that the moves would be carefully planned and that transport would be laid on for visits to Leamington Spa in the interim period.
- Some other concerns were raised about staffing and the quality of current care. Obviously this is a situation must be closely monitored in the coming months.

District Councillor Mrs H Wright reported the following;

- **Draft Core Strategy** The current strategy date for submission has been put back and the period the plan covers extended to 2031. In addition the original figure for housing of 9875 adopted by the administration will have to be revised upwards.
- On this issue the current figure that Stratford upon Avon District Council has spent on outside consultants is £572,200 and it is estimated a further expenditure between £120,000 and £150,000 will be spent.
- The new timetable will be announced in January 2014.
- On 9th October the Planning Policy manager met with his counterpart from Birmingham City Council. The conclusion reached at the meeting was there was cross boundary issues.
- It is however too early to hypothesise about meeting any housing requirements for Birmingham. A full appraisal of the evidence has to be seen before any discussion can be considered.
- **Planning Appeals** the Council is incurring costs in fighting planning appeals. This is estimated £414,638 excluding officer costs.
- The Planning Committee often realise the impact development will have on the District and are refusing grants, but on appeal the developer mostly wins as the result of a lack of a five year land supply.
- Section 106 Agreement- A site in Allimore Lane Alcester is to be developed requiring contribution of £17,000 from a section 106 Agreement. It has been decided that the money will go towards the refurbishment of Stratford Leisure Centre and not spent in Alcester.
- It is important for the Parish Council to note this as it can in the future have implications for the way Section 106 agreement are dealt with in Studley.
