SDC going through the budget, proposals still under discussion which then have to be considered by the Overview & Scrutiny Committee. Council in a dilemma as Government sending out directions. Muddled thinking at present as many changes. No definite decisions.

Cllr Weddell: Conflicting evidence from Government. Cabinet meeting on Friday.

County Council Report given by Cllr Rickhards

Plans to close 10 residential care homes. All kinds of options. Development that Four Acres will not close until 2013. Seems viable that would be taken over as a going concern.

Cllr Mrs Wright: understands that Studley is vulnerable as has alternative homes. The Woodlands and Field View have 54 beds making alternative provision. WCC relinquishing provision of care homes but if agreement reached some may be sold.

Cllr Rickhards: concerned for residents with dementia as doubt that even with domiciliary care may not cope. If Four Acres does close residents may be housed elsewhere if costs can be met. Not sure what the situation will be concerning the building may be sold or rented. Cllr Rickhards will keep the Parish Council informed.

Youth Club: seen evidence that the Youth Club will be saved on a short term basis as part of the Total Place Project. Meeting on Saturday, 12th February 2011 where adults and youths will be invited to give ideas.

Library: no news except that 6 libraries in the County will be closing. Budget will be determined on15th February 2011.
