- 2. Encourage householders to recycle and compost preferably at home, but then through collection authority schemes.
- 3. Dispose of some suitable waste to incineration and composting.
- Recover energy through thermal treatment.
- 5. Dispose of fly ash to landfill with a target of 5%.
