Minutes of the Parish Council meeting held in the Council Chamber, Studley Village Hall on 18th November 2014 at 7:30 pm.

1. Chairman declared the meeting open.

4. Public Forum

- I. Mr Dixon informed Council that the Studley Residents Against Graveyard Rules expressed their regret over the resignation of Cllr J Bacon.
 - Mr Dixon would like Council to take a vote to revoke the new rules for the cemetery based on the following reasons;
 - The consultation for the rules of the cemetery was flawed.
 - Only 4 residents were in favour of the new rules and 1 against.
 - The Parish Council did not take into consideration that 8 or 9 people raised their concerns, on the new rules, at Council meetings during the consultation period.

Mr Dixon would like a copy of the independent report by Mr Eggington regarding a previous matter with the graveyard. He would like to obtain this report under the Freedom of Information Act.

II. Mr Colin Summers informed the Council that he and another member from the Studley Residents Against Graveyard Rules had a meeting with 2 officials from Stratford District Council regarding the protocol, timing and other details for a Parish Meeting. The Group have decided that they do not want to hold a Parish Meeting now. They would like to have a meeting with the Parish Council to resolve the issue as soon as possible. He reiterated that the group have 1200 signatures on the petition and the numbers is rising and if this does not show the level of feelings in the community then the Parish Councillors are massively out of touch with the residents.

He also informed the Council that the Group is an irresistible force and they will not 'go away' until a resolution is reached between the Council and the group.

Mr Colin Summers would like Council to consider his 3 part proposal.

• The rules this Council has brought in should be rescinded forthwith.

Cllr J Ingram informed Mr Summers that the Parish Council cannot vote on issues raised by residents during public forum. - Studley Children Centre- Parenting Project £2,000.00

Adult Care

- There will be an increase in charges for the service. For areas that have not had an increase changes will apply.
- RESPITE residential care is charged at £51.80 per day. The rate of a £100.00 per day will be capped till January. Full cost charges will apply in April when capping will be removed.
- The service is means tested. As a result 80% of people will not have to pay.

Fire & Rescue

- Project ARROW which prescribes various levels of collaboration between the Fire services of Hereford, Worcestershire and Warwickshire. This collaboration has work streams including operational support, health & safety. Cllr Rickhards believes this project will benefit the area.
- There is a further option of full collaboration eventually.

Studley Centre

- Cllr Rickhards is still pursuing a decision from County Council if the Education Department will be housing their project in the Centre.
- Churches Together will be able to use the building for a café if County Council do not require the building.

School

- The school sufficiency strategy is published.
- The Studley cluster primary schools face a small reduction in forecast numbers over the next 5 years. Cllr Rickhards has questioned the Cabinet how far the impact of the
