- Has been pressing for 18+ Staying-put Family Placements.
- There are 450-500 children in care at any one time.
- Pleased to be associated with the Adoption Panel. Everything possible is done to keep families together, no decision is taken lightly.
- All Councillors are 'Virtual Parents' if something is not good enough for their children it is not good enough for children in care.
- At present there is no support after the age of 18 years. The County Council is undertaking a pilot study that at age 18 children do not have to leave their placement. They can stay with foster parents or a family placement if they want to.
- They will not get allowances but will get support if not working.
- Will be reviewed every 6 months.
- Children in Care Committee is made up of young people in care with Officers. It is a good system, a step forwarded.

Cllr Rickhards proposed a vote of thanks to Cllr Mrs McCarthy as the tenure of office comes to an end for the excellent and entertaining communications.

Summary:

Dog Fouling Bin and extra street lighting footpath between Green Close and Allendale Crescent

- Letter received from District Councillor Hazel Wright concerning a request at the last Orbit Housing Association Residents meeting for a Dog Fouling bin and a Street Light on the foothpath leading from Green Close to Allendale Avenue to deter youths from gathering in that area.
- The Police are not in favour of this request as they cannot approach groups of youths quietly and often street lights encourage youths to gather under them as has been experienced in the past. Proposed that the Clerk meet with Bob Yarwood, Lighting Officer, WCC to seek advice if a new light is needed and where the best position for the light would be.
- The request for light in Willow Way. Committee decided there was probably enough light from the existing lamps on Watts Road and Allendale.
- Clerk has met with Bob Yarwood and looked at the area. The only place a new light could be put is on Orbit Housing land. Therefore any request should be forwarded to them.
- Clerk to inform Cllr Mrs Wright.
